A BILL

To amend the Internal Revenue Code of 1986 to exempt survivor benefit annuity plan payments from the individual alternative minimum tax.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Children of Fallen
5 Warriors AMT Relief Act”.

1 **SEC. 2. EXEMPTION FOR SURVIVOR BENEFIT ANNUITY**
2 **PLAN PAYMENTS FROM THE INDIVIDUAL AL-**
3 **TERNATIVE MINIMUM TAX.**

4 (a) **IN GENERAL.**—Section 59(j)(1) of the Internal
5 Revenue Code of 1986 is amended by adding at the end
6 the following new flush sentence:

7 “Solely for purposes of this subsection, any annuity
8 paid under the Survivor Benefit Plan under sub-
9 chapter II of chapter 73 of title 10, United States
10 Code, shall be considered earned income of such
11 child.”.

12 (b) **EFFECTIVE DATE.**—The amendment made by
13 this section shall apply to taxable years beginning after
14 the date of the enactment of this Act.
