A BILL

To require the Comptroller General of the United States to carry out a study on procurement under the American Recovery and Reinvestment Act of 2009.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. STUDY BY COMPTROLLER GENERAL.
- 4 (a) Definitions.—In this Act—
- 5 (1) the terms "HUBZone small business con-
- 6 cern", "small business concern", "small business
- 7 concern owned and controlled by service-disabled
- 8 veterans", and "small business concern owned and
- 9 controlled by women" have the meaning given those

1	terms under section 3 of the Small Business Act (15
2	U.S.C. 632);
3	(2) the term "minority business enterprise"
4	means a small business concern that is uncondition-
5	ally owned, controlled, and managed by an individual
6	who is—
7	(A) a Black American;
8	(B) a Hispanic American;
9	(C) a Native American, including an Amer-
10	ican Indian, Eskimo, Aleut, or Native Hawai-
11	ian;
12	(D) an Asian Pacific American, including
13	an individual having origins in any of the origi-
14	nal peoples of Myanmar, Thailand, Malaysia,
15	Indonesia, Singapore, Brunei, Japan, China
16	(including Hong Kong), Taiwan, Laos, Cam-
17	bodia (Kampuchea), Vietnam, North Korea,
18	South Korea, the Philippines, a United States
19	Trust Territory of the Pacific Islands (including
20	the Republic of Palau), the Republic of the
21	Marshall Islands, the Federated States of Mi-
22	cronesia, the Commonwealth of the Northern
23	Mariana Islands, Guam, Samoa, Macao, Fiji,
24	Tonga, Kiribati, Tuvalu, or Nauru;

1	(E) a Subcontinent Asian American, in-
2	cluding an individual having origins in any of
3	the original peoples of India, Pakistan, Ban-
4	gladesh, Sri Lanka, Bhutan, the Maldives Is-
5	lands, or Nepal; or
6	(F) a member of another minority group,
7	as determined by the Administrator of the
8	Small Business Administration;
9	(3) the term "qualified HUBZone small busi-
10	ness concern' means a HUBZone small business
11	concern that is qualified under section $3(p)(5)$ of the
12	Small Business Act (15 U.S.C. 632(p)(5)); and
13	(4) the term "small business concern owned
14	and controlled by socially and economically disadvan-
15	taged individuals" has the meaning given that term
16	in section $8(d)(3)(C)$ of the Small Business Act (15
17	U.S.C. $637(d)(3)(C)$).
18	(b) STUDY REQUIRED.—The Comptroller General of
19	the United States shall carry out a study on the participa-
20	tion of small business concerns owned and controlled by
21	socially and economically disadvantaged individuals, mi-
22	nority business enterprises, and small business concerns
23	owned and controlled by women in procurement contracts
24	awarded using funds made available under division A of

1	the American Recovery and Reinvestment Act of 2009
2	(Public Law 111–5; 123 Stat. 116), which shall include—
3	(1) determining the percentage of all contracts
4	awarded by Federal agencies and departments using
5	funds made available under the American Recovery
6	and Reinvestment Act of 2009 (Public Law 111–5)
7	that were awarded to—
8	(A) small business concerns owned and
9	controlled by socially and economically dis-
10	advantaged individuals;
11	(B) minority business enterprises; and
12	(C) small business concerns owned and
13	controlled by women; and
14	(2) evaluating whether Federal agencies and de-
15	partments have met the Government-wide goals es-
16	tablished under section 15(g) of the Small Business
17	Act (15 U.S.C. 644(g)) for procurement contracts
18	awarded to small business concerns, small business
19	concerns owned and controlled by service-disabled
20	veterans, qualified HUBZone small business con-
21	cerns, small business concerns owned and controlled
22	by socially and economically disadvantaged individ-
23	uals, and small business concerns owned and con-
24	trolled by women, with respect to procurement con-
25	tracts awarded using funds made available under di-

- 2 ment Act of 2009 (Public Law 111–5; 123 Stat.
- 3 116).
- 4 (c) Report.—Not later than 120 days after the date
- 5 of enactment of this Act, the Comptroller General shall
- 6 submit to Congress a report on the results of the study
- 7 required under subsection (b).
