A BILL

To amend title 23, United States Code, to improve highway mobility in rural States for the benefit of all States.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Rural Mobility and
- 5 Access for America Act".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds that—
- 8 (1) Federal-aid highways in rural States—

1	(A) serve as a connection for truck and
2	personal traffic between other States and be-
3	tween major metropolitan areas, advancing
4	interstate commerce and mobility and benefit-
5	ting individuals in major metropolitan areas;
6	(B) enable agricultural exports and serve
7	the ethanol production and energy extraction
8	industries of the United States, which are lo-
9	cated largely in rural areas;
10	(C) are a lifeline for remotely located and
11	economically challenged citizens, such as those
12	living on Indian reservations;
13	(D) enable people and business to traverse
14	the large tracts of sparsely populated land that
15	are a major characteristic of many rural States;
16	and
17	(E) provide access to scenic wonders and
18	facilitate tourism;
19	(2) Federal investment in highways in rural
20	States enables enhanced investment to address safe-
21	ty needs on rural routes; and
22	(3) rural States with low population density and
23	extensive highway networks have fewer individuals to
24	support each lane mile of Federal-aid highway than

an average State.

1	SEC. 3. RURAL MOBILITY AND ACCESS FOR AMERICA PRO-
2	GRAM.
3	(a) In General.—Subchapter I of chapter 1 of title
4	23, United States Code, is amended by adding at the end
5	the following:
6	"§ 167. Rural Mobility and Access for America pro-
7	gram
8	"(a) Definition of Rural State.—In this section,
9	the term 'rural State' means any of the 50 States that—
10	"(1) has a population density of 45 or fewer in-
11	dividuals per square mile of land area; or
12	"(2) does not include, within the borders of the
13	State, a plurality of the population of a metropolitan
14	planning area served by a metropolitan planning or-
15	ganization under section 134 that encompasses, in
16	whole or part, an urbanized area with a population
17	of more than 500,000 individuals.
18	"(b) Establishment.—The Secretary shall estab-
19	lish and implement a program to benefit the surface trans-
20	portation system in the United States by allocating funds
21	to rural States.
22	"(c) STATE ALLOCATIONS.—
23	"(1) In general.—Funds authorized to be ap-
24	propriated for the program established under sub-
25	section (b) shall be allocated for each fiscal year
26	among rural States equally.

1	"(2) Use of decennial census data.—In
2	determining the population density of States or the
3	population of urbanized areas for the purpose of this
4	section, the Secretary shall use data contained in the
5	latest decennial census.
6	"(d) USE OF FUNDS.—Funds allocated to a State for
7	the program established under subsection (b)—
8	"(1) may be used for any type of project eligi-
9	ble under section 133(b); and
10	"(2) are not subject to other provisions of sec-
11	tion 133.
12	"(e) Authorization of Appropriations.—
13	"(1) In general.—There is authorized to be
14	appropriated to carry out this section from the
15	Highway Trust Fund (other than the Mass Transit
16	Account), for fiscal year 2010 and each fiscal year
17	thereafter, the amount determined under paragraph
18	(2), which shall—
19	"(A) be used to carry out the program
20	under this section;
21	"(B) remain available until expended;
22	"(C) be available for obligation as if the
23	funds were apportioned under this chapter; and
24	"(D) not be subject to any limitation on
25	obligations.

1	"(2) Amount.—The amount referred to in
2	paragraph (1) is, for a fiscal year, 33½ percent of
3	the amount of funds for that fiscal year authorized
4	to be allocated to those metropolitan planning orga-
5	nizations that serve a metropolitan planning area
6	that encompasses, in whole or part, an urbanized
7	area with a population of more than 500,000 indi-
8	viduals.".

9 (b) Conforming Amendment.—The analysis for 10 chapter 1 of title 23, United States Code, is amended by 11 adding at the end of the items relating to subchapter I 12 the following:

"167. Rural Mobility and Access for America program.".
