## A BILL

For the relief of Alemseghed Mussie Tesfamical.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PERMANENT RESIDENT STATUS FOR
- 4 ALEMSEGHED MUSSIE TESFAMICAL.
- 5 (a) In General.—Notwithstanding subsections (a)
- 6 and (b) of section 201 of the Immigration and Nationality
- 7 Act (8 U.S.C. 1151) and section 240 of such Act (8
- 8 U.S.C. 1229a), Alemseghed Mussie Tesfamical shall be el-
- 9 igible for issuance of an immigrant visa or for adjustment
- 10 of status to that of an alien lawfully admitted for perma-
- 11 nent residence upon filing an application for issuance of
- 12 an immigrant visa under section 204 of such Act (8

- 1 U.S.C. 1154) or for adjustment of status to lawful perma-
- 2 nent resident.
- 3 (b) Adjustment of Status.—If Alemseghed
- 4 Mussie Tesfamical enters the United States before the fil-
- 5 ing deadline specified in subsection (c), Alemseghed
- 6 Mussie Tesfamical shall be considered to have entered and
- 7 remained lawfully and, if otherwise eligible, shall be eligi-
- 8 ble for adjustment of status under section 245 of the Im-
- 9 migration and Nationality Act (8 U.S.C. 1255) as of the
- 10 date of the enactment of this Act.
- 11 (c) Deadline for Application and Payment of
- 12 Fees.—Subsections (a) and (b) shall apply only if the ap-
- 13 plication for issuance of an immigrant visa or the applica-
- 14 tion for adjustment of status is filed with appropriate fees
- 15 not later than 2 years after the date of the enactment of
- 16 this Act.
- 17 (d) Reduction of Immigrant Visa Number.—
- 18 Upon the granting of an immigrant visa or permanent res-
- 19 idence to Alemseghed Mussie Tesfamical, the Secretary of
- 20 State shall instruct the proper officer to reduce by 1, dur-
- 21 ing the current or next following fiscal year, the total num-
- 22 ber of immigrant visas that are made available to natives
- 23 of the country of Alemseghed Mussie Tesfamical's birth
- 24 under section 203(a) of the Immigration and Nationality
- 25 Act (8 U.S.C. 1153(a)) or, if applicable, the total number

- 1 of immigrant visas that are made available to natives of
- 2 the country of Alemseghed Mussie Tesfamical's birth

3 under section 202(e) of such Act (8 U.S.C. 1152(e)).
