A BILL

Making emergency supplemental appropriations for border security for the fiscal year ending September 30, 2010, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 fiscal year ending September 30, 2010, and for other pur-
- 6 poses, namely:

2	DEPARTMENT OF HOMELAND SECURITY
3	U.S. Customs and Border Protection
4	SALARIES AND EXPENSES
5	For an additional amount for "Salaries and Ex-
6	penses", \$253,900,000, to remain available until Sep-
7	tember 30, 2011, of which \$39,000,000 shall be for costs
8	to maintain U.S. Customs and Border Protection Officer
9	staffing on the Southwest Border of the United States,
10	\$29,000,000 shall be for hiring additional U.S. Customs
11	and Border Protection Officers for deployment at ports
12	of entry on the Southwest Border of the United States,
13	\$175,900,000 shall be for hiring additional Border Patrol
14	agents for deployment to the Southwest Border of the
15	United States, and \$10,000,000 shall be to support integ-
16	rity and background investigation programs.
17	BORDER SECURITY FENCING, INFRASTRUCTURE, AND
18	TECHNOLOGY
19	For an additional amount for "Border Security Fenc-
20	ing, Infrastructure, and Technology," \$14,000,000, to re-
21	main available until September 30, 2011, for costs of de-
22	signing, building, and deploying tactical communications
23	for support of enforcement activities on the Southwest
24	Border of the United States.

AIR AND MARINE INTERDICTION, OPERATIONS,
MAINTENANCE, AND PROCUREMENT
For an additional amount for "Air and Marine Inter-
diction, Operations, Maintenance, and Procurement"
\$32,000,000, to remain available until September 30
2012, for costs of acquisition and deployment of un-
manned aircraft systems.
CONSTRUCTION AND FACILITIES MANAGEMENT
For an additional amount for "Construction and Fa
cilities Management", \$6,000,000, to remain available
until September 30, 2011, for costs to construct up to 2
forward operating bases for use by the Border Patrol to
carry out enforcement activities on the Southwest Border
of the United States.
U.S. Immigration and Customs Enforcement
SALARIES AND EXPENSES
For an additional amount for "Salaries and Ex-
penses", \$80,000,000, to remain available until September
30, 2011, of which \$30,000,000 shall be for law enforce
ment activities targeted at reducing the threat of violence
along the Southwest Border of the United States, and
\$50,000,000 shall be for hiring of additional agents, inves-
tigators, intelligence analysts, and support personnel.

2	SALARIES AND EXPENSES
3	For an additional amount for "Salaries and Ex-
4	penses", \$8,100,000, to remain available until September
5	30, 2011, for costs to provide basic training for new U.S.
6	Customs and Border Protection Officers, Border Patrol
7	agents, and U.S. Immigration and Customs Enforcement
8	personnel.
9	GENERAL PROVISIONS
10	(RESCISSION)
11	Sec. 101. From unobligated balances made available
12	to U.S. Customs and Border Protection "Border Security
13	Fencing, Infrastructure, and Technology", \$100,000,000
14	are rescinded: Provided, That section 401 shall not apply
15	to the amount in this section.

17	DEPARTMENT OF JUSTICE
18	Sec. 201. For an additional amount for the Depart-
19	ment of Justice for necessary expenses for increased law
20	enforcement activities related to Southwest Border en-
21	forcement, \$196,000,000, to remain available until Sep-
22	tember 30, 2011: Provided, That funds shall be distrib-
23	uted to the following accounts and in the following speci-
24	fied amounts:

15	SEC. 401. Each amount appropriated or otherwise

17	gency requirement and necessary to meet emergency needs
18	pursuant to sections 403(a) and 423(b) of S. Con. Res.
19	13 (111th Congress), the concurrent resolution on the
20	budget for fiscal year 2010.
21	SEC. 402. (a) Notwithstanding any other provision
22	of this Act or any other provision of law, during the period
23	beginning on the date of the enactment of this Act and
24	ending on September 30, 2014, the filing fee and fraud
25	prevention and detection fee required to be submitted with

- 2 tion 101(a)(15)(L) of the Immigration and Nationality
- 3 Act (8 U.S.C. 1101(a)(15)(L)) shall be increased by

- 9 (b) Notwithstanding any other provision of this Act
- 10 or any other provision of law, during the period beginning
- 11 on the date of the enactment of this Act and ending on
- 12 September 30, 2014, the filing fee and fraud prevention
- 13 and detection fee required to be submitted with an applica-
- 14 tion for admission as a nonimmigrant under section
- 15 101(a)(15)(H)(i)(b) of the Immigration and Nationality
- 16 Act (8 U.S.C. 1101(a)(15)(H)(i)(b)) shall be increased by
- 17 \$2,000 for applicants that employ 50 or more employees
- 18 in the United States if more than 50 percent of the appli-
- 19 cant's employees are such nonimmigrants or non-
- 20 immigrants described in section 101(a)(15)(L) of such
- 21 Act.
- (c) During the period beginning on the date of the
- 23 enactment of this Act and ending on September 30, 2014,
- 24 all amounts collected pursuant to the fee increases author-

- 1 ized under this section shall be deposited in the General
- 2 Fund of the Treasury.
