A BILL

To amend title 38, United States Code, to improve Servicemembers' Group Life Insurance and Veterans' Group Life Insurance and to modify the provision of compensation and pension to surviving spouses of veterans in the months of the deaths of the veterans, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

REPEAL OF SUNSET ON 2-YEAR EXTENSION OF 5 SERVICEMEMBERS' GROUP LIFE INSURANCE 6 **COVERAGE** FOR **MEMBERS** OF **ARMED** 7 FORCES SEPARATING FROM SERVICE WHILE 8 TOTALLY DISABLED. 9 (a) Separation or Release.—Paragraph (1)(A) of section 1968(a) of title 38, United States Code, is amend-10 11 ed by striking clause (ii) and inserting the following new 12 clause (ii): 13 "(ii) The date that is 2 years after the 14 date of separation or release from such ac-

tive duty or active duty for training, in the

2	ring on or after June 15, 2005.".
3	(b) Separation or Release From Certain Re-
4	SERVE ASSIGNMENTS.—Paragraph (4) of such section is
5	amended by striking subparagraph (B) and inserting the
6	following new subparagraph (B):
7	"(B) The date that is 2 years after the
8	date of separation or release from such assign-
9	ment, in the case of such a separation or re-
10	lease occurring on or after June 15, 2005.".
11	SEC. 102. AUTHORIZATION FOR INCREASES BY INDIVID-
12	UALS OF VETERANS' GROUP LIFE INSURANCE
13	COVERAGE UPON RENEWAL.
14	Section 1977(a) of title 38, United States Code, is
15	amended—
16	(1) in paragraph (1), by striking the second
17	sentence; and
18	(2) by adding at the end the following new
19	paragraph:
20	"(3) Subject to the second sentence of para-
21	graph (1), a veteran who has not attained the age
22	of 60 years and is insured under Veterans' Group
23	Life Insurance for an amount less than the max-
24	imum amount of Servicemembers' Group Life Insur-
25	ance in effect under section 1967(a)(3)(A)(i) of this

1	title at the time of renewal of Veterans' Group Life
2	Insurance under this section may increase the
3	amount of the veteran's coverage under Veterans'
4	Group Life Insurance by not more than \$25,000 at
5	the time of renewal.".
6	SEC. 103. MODIFICATION OF MONTH OF DEATH BENEFIT
7	FOR SURVIVING SPOUSES OF VETERANS WHO
8	DIE WHILE ENTITLED TO COMPENSATION OR
9	PENSION.
10	(a) Surviving Spouse Benefit for Month of
11	Veteran's Death.—Subsections (a) and (b) of section
12	5310 of title 38, United States Code, are amended to read
13	as follows:
14	"(a) In General.—(1) A surviving spouse of a vet-
15	eran is entitled to a benefit for the month of the veteran's
16	death if at the time of the veteran's death—
17	"(A) the veteran was receiving compensation or
18	pension under chapter 11 or 15 of this title; or
19	"(B) the veteran was not receiving compensa-
20	tion or pension under chapter 11 or 15 of this title
21	but the veteran had a claim pending for the month
22	of the veteran's death for which benefits would have
23	been payable under chapter 11 or 15 of this title
24	had the veteran not died.

- 1 "(2) The amount of benefit under paragraph (1) is
- 2 the amount that the veteran would have received under
- 3 chapter 11 or 15 of this title for the month of the vet-
- 4 eran's death had the veteran not died.
- 5 "(3) Any benefits payable under this section on be-
- 6 half of a veteran who was not in receipt of such benefits
- 7 as of the month of the veteran's death shall be paid to
- 8 the surviving spouse as accrued benefits.
- 9 "(b) Claims Pending Adjudication.—If a claim
- 10 for entitlement to compensation or additional compensa-
- 11 tion under chapter 11 of this title or pension or additional
- 12 pension under chapter 15 of this title is pending at the
- 13 time of a veteran's death and the check or other payment
- 14 issued to the veteran's surviving spouse under subsection
- 15 (a) is less than the amount of the benefit the veteran
- 16 would have been entitled to for the month of death pursu-
- 17 ant to the adjudication of the pending claim, an amount
- 18 equal to the difference between the amount to which the
- 19 veteran would have been entitled to receive under chapter
- 20 11 or 15 of this title for the month of the veteran's death
- 21 had the veteran not died and the amount of the check or
- 22 other payment issued to the surviving spouse shall be
- 23 treated in the same manner as an accrued benefit under
- 24 section 5121 of this title.".

- 1 (b) Month of Death Benefit Exempt From De-
- 2 LAYED COMMENCEMENT OF PAYMENT.—Section
- 3 5111(c)(1) of such title is amended by striking "apply to"
- 4 and all that follows through "death occurred" and insert-
- 5 ing the following: "not apply to payments made pursuant
- 6 to section 5310 of this title".
- 7 (c) Prohibition on Requests for Return of
- 8 CERTAIN CHECKS AND PAYMENTS.—In the case of a sur-
- 9 viving spouse who was a dependent with respect to whom
- 10 additional compensation for dependents was payable under
- 11 section 1115 of title 38, United States Code, or additional
- 12 pension as a married veteran under chapter 15 of such
- 13 title, as of the date of the veteran's death, if a check or
- 14 other payment issued to the veteran as a benefit payment
- 15 under chapter 11 or 15 of title 38, United States Code,
- 16 for the month in which death occurs is negotiated, depos-
- 17 ited, or otherwise accessed by the surviving spouse—
- 18 (1) the check or payment shall be considered to
- be the benefit payable to the surviving spouse under
- section 5310(a)(1) of title 38, United States Code
- 21 (as amended by subsection (a)), to the extent that
- 22 the check or payment equals the amount which
- 23 would otherwise be payable under such section; and
- 24 (2) the Secretary may not require the surviving
- spouse to return the check or payment.

2	this section shall take effect on the date of the enactment
3	of this Act, and shall apply with respect to deaths that
4	occur on or after that date.
5	SEC. 104. ELIGIBILITY FOR PRESIDENTIAL MEMORIAL CER-
6	TIFICATES OF INDIVIDUALS WHO DIE WHILE
7	SERVING IN THE ACTIVE MILITARY, NAVAL,
8	OR AIR SERVICE.
9	Section 112 of title 38, United States Code, is
10	amended—
11	(1) by amending subsection (a) to read as fol-
12	lows:
13	"(a)(1) At the request of the President, the Secretary
14	may conduct a program for honoring the memory of cov-
15	ered individuals by preparing and sending to eligible re-
16	cipients a certificate bearing the signature of the Presi-
17	dent and expressing the country's recognition of the cov-
18	ered individual's service in the Armed Forces.
19	"(2) The award of a certificate to one eligible recipi-
20	ent shall not preclude authorization of another certificate
21	if a request is received from some other eligible recipient.";
22	(2) by redesignating subsections (b) and (c) as
23	subsections (c) and (d), respectively; and
24	(3) by inserting after subsection (a) the fol-
25	lowing new subsection (b):

1	"(b) For purposes of this section, a covered individual
2	is any of the following:
3	"(1) A deceased veteran discharged under hon-
4	orable conditions.
5	"(2) An individual who dies while serving in the
6	active military, naval, or air service.".

9	SEC. 201. OCCUPANCY OF PROPERTY BY DEPENDENT
10	CHILD OF A VETERAN.
11	Paragraph (2) of section 3704(c) of title 38, United
12	States Code, is amended to read as follows:
13	"(2) In any case in which a veteran is in active duty
14	status as a member of the Armed Forces and is unable
15	to occupy a property because of such status, the occupancy
16	requirements of this chapter shall be considered to be sat-
17	isfied if—
18	"(A) the veteran's spouse occupies or intends to
19	occupy the property as a home and the spouse
20	makes the certification required by paragraph (1) of
21	this subsection; or
22	"(B) the veteran's dependent child occupies or
23	will occupy the property as a home and the veteran's
24	attorney-in-fact or a legal guardian of the veteran's

1	dependent child makes the certification required by
2	paragraph (1) of this subsection.".
3	SEC. 202. COVENANTS AND LIENS CREATED BY PUBLIC EN-
4	TITIES IN RESPONSE TO DISASTER-RELIEF
5	ASSISTANCE.
6	Paragraph (3) of section 3703(d) of title 38, United
7	States Code, is amended to read as follows:
8	"(3)(A) Any real estate housing loan (other than for
9	repairs, alterations, or improvements) shall be secured by
10	a first lien on the realty. In determining whether a loan
11	is so secured, the Secretary may either disregard or allow
12	for subordination to a superior lien created by a duly re-
13	corded covenant running with the realty in favor of—
14	"(i) a public entity that has provided or will
15	provide assistance in response to a major disaster as
16	declared by the President under section 401 of the
17	Robert T. Stafford Disaster Relief and Emergency
18	Assistance Act (42 U.S.C. 5170); or
19	"(ii) a private entity to secure an obligation to
20	such entity for the homeowner's share of the costs
21	of the management, operation, or maintenance of
22	property, services, or programs within and for the
23	benefit of the development or community in which
24	the veteran's realty is located, if the Secretary deter-
25	mines that the interests of the veteran horrower and

- of the Government will not be prejudiced by the op-
- 2 eration of such covenant.
- 3 "(B) With respect to any superior lien described in
- 4 subparagraph (A) created after June 6, 1969, the Sec-
- 5 retary's determination under clause (ii) of such subpara-
- 6 graph shall have been made prior to the recordation of
- 7 the covenant.".

- 9 SEC. 301. PROCESSING OF APPLICATIONS FOR RELIEF
- 10 FROM ADJUDICATION OF MENTAL INCOM-
- 11 PETENCE FOR CERTAIN PURPOSES.
- 12 (a) IN GENERAL.—Chapter 55 of title 38, United
- 13 States Code, is amended by adding at the end the fol-
- 14 lowing new section:
- 15 "§ 5511. Processing of applications for relief from ad-
- judication of mental incompetence for
- 17 **certain purposes**
- "Notwithstanding clause (ii) of section 101(c)(2)(A)
- 19 of the NICS Improvement Amendments Act of 2007 (Pub-
- 20 lie Law 110–180; 18 U.S.C. 922 note), each application
- 21 for relief submitted to the Secretary under the program
- 22 required by clause (i) of such section shall be processed
- 23 by the Secretary not later than 180 days after the receipt
- 24 of the application. If the Secretary fails to resolve such
- 25 application for relief within 180 days for any reason, in-

- 1 cluding a lack of appropriated funds, the Secretary shall
- 2 be deemed to have granted such application for relief.".
- 3 (b) CLERICAL AMENDMENT.—The table of sections
- 4 at the beginning of chapter 55 of such title is amended
- 5 by adding at the end the following new item:
 - "5511. Processing of applications for relief from adjudication of mental incompetence for certain purposes.".
