To extend the final report deadline and otherwise reauthorize the National Commission on Children and Disasters.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Commission
- 5 on Children and Disasters Reauthorization Act of 2010".
- 6 SEC. 2. NATIONAL COMMISSION ON CHILDREN AND DISAS-
- 7 TERS REAUTHORIZATION.
- 8 (a) Deadline for Filling Vacancies.—Para-
- 9 graph (2) of section 605(g) of the Kids in Disasters Well-
- 10 being, Safety, and Health Act of 2007 (title VI of division

- 1 G of the Consolidated Appropriations Act, 2008 (Public
- 2 Law 110–161; 121 Stat. 1844, 2213)) is amended by in-
- 3 serting "not later than 90 days after the date of vacancy"
- 4 after "shall be filled".
- 5 (b) Frequency of Interim Reports.—Subsection
- 6 (a) of section 611 of the Kids in Disasters Well-being,
- 7 Safety, and Health Act of 2007 is amended—
- 8 (1) in the subsection heading, by striking "In-
- 9 TERIM REPORT" and inserting "INTERIM RE-
- 10 PORTS"; and
- 11 (2) by inserting "and annually thereafter" after
- "first meeting".
- 13 (c) Deadline for Final Report.—Subsection (c)
- 14 of section 611 of the Kids in Disasters Well-being, Safety,
- 15 and Health Act of 2007 is amended by striking "not later
- 16 than 2 years after the date of its first meeting" and insert-
- 17 ing "not later than December 31, 2012".
- 18 (d) Authorization of Appropriations.—Section
- 19 612 of such Act is amended to read as follows:
- 20 "SEC. 612. AUTHORIZATION OF APPROPRIATIONS.
- 21 "(a) In General.—There is authorized to be appro-
- 22 priated to carry out this title \$1,500,000 for each of fiscal
- 23 years 2011 and 2012, and \$1,000,000 for fiscal year
- 24 2013.

- 1 "(b) AVAILABILITY.—Amounts made available pursu-
- 2 ant to subsection (a) shall remain available until ex-
