A BILL

To amend the Education Sciences Reform Act of 2002 to require the Statistics Commissioner to collect information from coeducational secondary schools on such schools' athletic programs, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "High School Sports
- 5 Information Collection Act of 2009".

1	SEC. 2. STATISTICS ON EQUALITY IN ATHLETIC PROGRAMS.
2	Section 153 of the Education Sciences Reform Act
3	of 2002 (20 U.S.C. 9543) is amended by adding at the
4	end the following:
5	"(c) Equality in Athletic Programs.—
6	"(1) In General.—The Statistics Commis-
7	sioner shall collect, annually, for the immediately
8	preceding academic year, from each coeducational
9	secondary school that receives Federal financial as-
10	sistance that has an athletic program, the following
11	information:
12	"(A) The number of male and female stu-
13	dents that attended the school and for each stu-
14	dent an identification of such student's—
15	"(i) race; and
16	"(ii) ethnicity.
17	"(B) A listing of the teams that competed
18	in athletic competition and for each such team
19	the following data:
20	"(i) The season in which the team
21	competed.
22	"(ii) The total number of participants
23	as of the day of the first scheduled contest
24	for the team, and for each participant an
25	identification of such participant's—
26	"(I) gender;

1	"(II) race; and
2	"(III) ethnicity.
3	"(iii) The total expenditures for the
4	team, including the following data:
5	"(I) The travel expenditures.
6	"(II) The equipment expendi-
7	tures (including any equipment re-
8	placement schedule).
9	"(III) The uniform expenditures
10	(including any uniform replacement
11	schedule).
12	"(IV) The expenditures for facili-
13	ties, including medical facilities, locker
14	rooms, fields, and gymnasiums.
15	"(V) The total number of train-
16	ers and medical personnel, and for
17	each trainer or medical personnel an
18	identification of such person's—
19	"(aa) gender;
20	"(bb) employment status
21	(including whether such person is
22	employed full-time or part-time,
23	and whether such person is a
24	head or assistant trainer or med-
25	ical services provider) and duties

1	other than providing training or
2	medical services; and
3	"(ce) qualifications, includ-
4	ing whether the person is a pro-
5	fessional or student.
6	"(VI) The expenditures for pub-
7	licity for competitions.
8	"(iv) The total number of coaches,
9	and for each coach an identification of
10	such coach's—
11	"(I) gender;
12	"(II) employment status (includ-
13	ing whether such coach is employed
14	full-time or part-time, and whether
15	such coach is a head or assistant
16	coach) and duties other than coach-
17	ing; and
18	"(III) qualifications, including
19	whether the person is a professional
20	or student.
21	"(v) The total number of competitions
22	scheduled, and for each scheduled competi-
23	tion an indication of what day of the week
24	and time the competition was scheduled.

1	"(vi) Whether such team participated
2	in postseason competition, and the success
3	of such team in any postseason competi-
4	tion.
5	"(vii) The total number of practices
6	scheduled, and for each scheduled practice
7	an indication of what day of the week and
8	time the practice was scheduled.
9	"(2) Disclosure of information to stu-
10	DENTS AND PUBLIC.—A coeducational secondary
11	school described in paragraph (1) shall—
12	"(A) make available to students and poten-
13	tial students, upon request, and to the public,
14	the information contained in reports by the
15	school under this subsection by October 15 of
16	each school year; and
17	"(B) ensure that all students at the school
18	are informed of their right to request such in-
19	formation.
20	"(3) Submission; information avail-
21	ABILITY.—On an annual basis, each coeducational
22	secondary school described in paragraph (1) shall
23	provide the information contained in each report by
24	the school under this subsection to the Statistics
25	Commissioner not later than 15 days after the date

1	that the school makes such information available
2	under paragraph (2).
3	"(4) Duties of commissioner for edu-
4	CATION STATISTICS.—The Statistics Commissioner
5	shall—
6	"(A) ensure that reports under this sub-
7	section are posted on the Department of Edu-
8	cation's website within a reasonable period of
9	time; and
10	"(B) not later than 180 days after the
11	date of enactment of the High School Sports
12	Information Collection Act of 2009—
13	"(i) notify all secondary schools in all
14	States regarding the availability of infor-
15	mation under paragraph (2); and
16	"(ii) issue guidance to all schools on
17	how to collect and report the information
18	required under this subsection.".
