A BILL

To amend the provisions of law relating to the John H. Prescott Marine Mammal Rescue Assistance Grant Program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Marine Mammal Res-
- 5 cue Assistance Amendments of 2009".

SEC. 2. STRANDING AND ENTANGLEMENT RESPONSE. 2 (a) Collection and Updating of Informa-3 TION.—Section 402(b)(1)(A) of the Marine Mammal Protection Act of 1972 (16 U.S.C. 1421a(b)(1)(A)) is amend-4 5 ed by inserting "or entangled" after "stranded". 6 (b) Entanglement Response Agreements.— 7 (1) IN GENERAL.—Section 403 of that Act (16) 8 U.S.C. 1421b) is amended— 9 (A) by striking the section heading and in-10 serting the following: 11 "SEC. 403. STRANDING OR ENTANGLEMENT RESPONSE 12 AGREEMENTS."; 13 and (B) by striking "stranding." in subsection 14 15 (a) and inserting "stranding or entanglement.". 16 (2) CLERICAL AMENDMENT.—The table of con-17 tents for title IV of that Act is amended by striking 18 the item relating to section 403 and inserting the 19 following: "Sec. 403. Stranding or entanglement response agreements.". 20 (c) Liability.—Section 406(a) of such Act (16) U.S.C. 1421e(a)) is amended by inserting "or entanglement" after "stranding". 23 (d) Entanglement Defined.— (1) IN GENERAL.—Section 410 of such Act (16 24 25 U.S.C. 1421h) is amended—

17	(f) John H. Prescott Marine Mammal Rescue					
18	AND RESPONSE FUNDING PROGRAM.—					
19	(1) Authorization of appropriations.—					
20	Section 408(h) of such Act (16 U.S.C. 1421f–1(h))					
21	is amended to read as follows:					
22	"(h) Authorization of Appropriations.—					
23	"(1) In general.—There are authorized to be					
24	appropriated to carry out this section, other than					
25	subsection (a)(3), \$7,000,000 for each of fiscal years					

1	2010 through 2014, to remain available until ex-
2	pended, of which—
3	"(A) \$6,000,000 may be available to the
4	Secretary of Commerce; and
5	"(B) \$1,000,000 may be available to the
6	Secretary of the Interior.
7	"(2) Rapid response fund.—There are au-
8	thorized to be appropriated to the John H. Prescott
9	Marine Mammal Rescue and Rapid Response Fund
10	established by subsection (a)(3), \$500,000 for each
11	of fiscal years 2010 through 2014.
12	"(3) Additional rapid response funds.—
13	There shall be deposited into the Fund established
14	by subsection (a)(3) up to \$500,000 per fiscal year
15	(as determined by the Secretary) from amounts ap-
16	propriated to the Secretary for carrying out this title
17	and the other titles of this Act.".
18	(2) Administrative costs and expenses.—
19	Section $408(f)$ of such Act $(16$ U.S.C. $1421f-1(f))$
20	is amended to read as follows:
21	"(f) Administrative Costs and Expenses.—Of
22	the amounts available each fiscal year to carry out this
23	section, the Secretary may expend not more than 6 per-
24	cent or \$80,000, whichever is greater, to pay the adminis-
25	trative costs and administrative expenses to implement the

- 1 program under subsection (a). Any such funds retained
- 2 by the Secretary for a fiscal year for such costs and ex-
- 3 penses that are not used for such costs and expenses be-
- 4 fore the end of the fiscal year shall be provided under sub-
- 5 section (a).".
- 6 (3) Emergency assistance.—Section 408 of
- 7 such Act (16 U.S.C. 1421f–1) is amended—

- 15 recovery or treatment of marine mammals, the collection
- 16 of data from living or dead stranded or entangled marine

22	activity conducted with funds under this section
23	shall be 25 percent of such Federal costs.
24	"(2) Waiver.—The Secretary shall waive the
25	requirements of paragraph (1) with respect to an ac-

1	tivity conducted with emergency funds disbursed
2	from the Fund established by subsection (a)(3).
3	"(3) In-kind contributions.—The Secretary
4	may apply to the non-Federal share of an activity
5	conducted with a grant under this section the
6	amount of funds, and the fair market value of prop-
7	erty and services, provided by non-Federal sources
8	and used for the activity."; and
9	(F) by redesignating paragraph (2) of sub-
10	section (g) as paragraph (3) and inserting after
11	paragraph (1) the following:
12	"(2) Emergency assistance.—The term
13	'emergency assistance' means assistance provided for
14	a stranding or entangling event—
15	"(A) that—
16	"(i) is not an unusual mortality event
17	as defined in section 409(7);
18	"(ii) leads to an immediate increase in
19	required costs for stranding or entangling
20	response, recovery, or rehabilitation in ex-
21	cess of regularly scheduled costs;
22	"(iii) may be cyclical or endemic; and
23	"(iv) may involve out-of-habitat ani-
24	mals; or

1	"(B) is found by the Secretary to qualify
2	for emergency assistance.".
3	(4) Contributions.—Section 408 of such Act

6	"(i) Contributions.—For purposes of carrying out
7	this section, the Secretary may solicit, accept, receive,
8	hold, administer, and use gifts, devises, and bequests with-
