### 3 SECTION 1. DIESEL EMISSIONS REDUCTION.

- 4 (a) AMENDMENTS.—Subtitle G of title VII of the En-

8	(B)"; and
9	(ii) by striking " <sup>1</sup> / <sub>53</sub> " and inserting

11	(B) by striking subparagraph (B) of para-

13	(C) by redesignating subparagraph (C) of
14	paragraph (2) as subparagraph (B); and
15	(D) by amending paragraph (4) to read as
16	follows:
17	"(4) Unclaimed funds.—
18	"(A) IN GENERAL.—Any funds that are
19	not claimed by a State for a fiscal year under
20	this subsection shall be used to carry out sec-

22	"(B) REALLOCATION AMONG TERRI-
23	TORIES.—Notwithstanding subparagraph (A),
24	any funds that are not claimed by a grantee or
25	loan recipient listed in subparagraph (C) for a

1	fiscal year may be reallocated by the Adminis-
2	trator among the grantees and loan recipients
3	listed in subparagraph (C) that have claimed all
4	funds allocated for such fiscal year. Any funds
5	so reallocated shall be for use in accordance
6	with this section.
7	"(C) LIST.—For purposes of subparagraph
8	(B), the grantees and loan recipients listed in
9	this subparagraph are the Commonwealth of
10	Puerto Rico, Guam, the United States Virgin
11	Islands, American Samoa, and the Common-
12	wealth of the Northern Mariana Islands.".
13	(b) APPLICATION.—Irrespective of the date of the en-
14	actment of this Act, the amendments made by this section
15	apply with respect to funding for fiscal year 2012 and
16	each subsequent fiscal year.
