## A BILL

- To amend the Public Health Service Act to provide for the national collection of data on stillbirths in a standardized manner, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "Stillbirth Awareness
  - 5 and Research Act of 2011".
  - 6 SEC. 2. NATIONAL STILLBIRTH REGISTRY.
  - 7 Part B of title III of the Public Health Service Act
  - 8 (42 U.S.C. 243 et seq.) is amended by inserting after sec-
- 9 tion 317T the following:

#### 1 "SEC. 317U. NATIONAL STILLBIRTH REGISTRY.

- 2 "(a) Establishment.—For the purposes described
- 3 in subsection (b), the Secretary, acting through the Direc-
- 4 tor of the Centers for Disease Control and Prevention,
- 5 shall, by grant or contract, establish and maintain a sci-
- 6 entific registry of stillbirths in the United States (in this
- 7 section referred to as the 'registry').
- 8 "(b) Purposes.—The purposes of the registry are—
- 9 "(1) to provide a national repository for report-
- ing and maintaining in a consistent manner data on
- stillbirths; and
- 12 "(2) to make such data available for research
- on the causes and prevention of stillbirths.
- 14 "(c) Content.—The registry shall include, with re-
- 15 spect to each stillbirth, information on the stillborn fetus
- 16 and the mother's health and pregnancy as collected and
- 17 submitted by States on the U.S. Standard Report of Fetal
- 18 Death. In submitting such information, the Director of the
- 19 Centers for Disease Control and Prevention shall require
- 20 States to use the standard definition of stillbirth and the
- 21 standard protocol for stillbirth data collection and surveil-
- 22 lance as determined pursuant to subsection (d).
- 23 "(d) Determination of Standard Stillbirth
- 24 Definition and Protocol.—

1	"(1) In general.—For purposes of this sec-
2	tion, the Secretary shall provide for the development
3	of the following:
4	"(A) A standard definition of stillbirth.
5	"(B) A standard protocol for stillbirth data
6	collection and surveillance.
7	"(2) Consultation.—The Secretary shall en-
8	sure that the standard definition and protocol de-
9	scribed paragraph (1) are developed under such
10	paragraph in a manner that ensures the consultation
11	of representatives of health care organizations, State
12	and local governments, and other interested entities
13	specified by the Secretary.".
14	SEC. 3. SENSE OF CONGRESS ON NIH FUNDING FOR STILL-
15	BIRTH RESEARCH.
16	It is the sense of the Congress that the Director of
17	the National Institutes of Health should increase the allo-
18	cation of funds and other resources for stillbirth research.
19	SEC. 4. NATIONAL PUBLIC AWARENESS CAMPAIGN.
20	(a) In General.—The Secretary of Health and
21	Human Services shall carry out a national campaign to
22	increase public awareness and knowledge of stillbirths and
23	public and State awareness of the standard stillbirth defi-

- 3 (b) Measures To Reduce the Incidence of
- 4 Stillbirths.—Activities under the national campaign
- 5 under subsection (a) shall include—
- 6 (1) the dissemination of information on meas-
- 7 ures for mothers to maintain a healthy pregnancy
- 8 and assess fetal health;
- 9 (2) the dissemination of information on good
- prenatal care practices such as not drinking alcohol
- or smoking; and
- 12 (3) the promotion of fetal movement awareness
- and taking proactive steps to monitor a baby's move-
- ment beginning at approximately 28 weeks into the
- 15 pregnancy.
- 16 SEC. 5. AUTHORIZATION OF APPROPRIATIONS.
- 17 (a) IN GENERAL.—To carry out this Act and the
- 18 amendment made by this Act, there is authorized to be
- 19 appropriated \$5,000,000 for each of fiscal years 2012
- 20 through 2016.
- 21 (b) Corresponding Reduction.—The aggregate
- 22 amount authorized to be appropriated by other provisions
- 23 of law to the Centers for Disease Control and Prevention

- 1 for business services support is reduced by \$5,000,000 for
- $2\,\,$  each of fiscal years 2012 through 2016.
