A BILL

To amend title 10, United States Code, to direct the Secretary of Defense to provide members of the Individual Ready Reserve, Individual Mobilization Augmentees, and inactive members of the National Guard who served in Afghanistan or Iraq with information on counseling to prevent suicide, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Sergeant Coleman S.
- 5 Bean Reserve Component Suicide Prevention Act".

1	SEC. 2. SUICIDE AMONG MEMBERS OF THE INDIVIDUAL
2	READY RESERVE AND INDIVIDUAL MOBILIZA
3	TION AUGMENTEES.
4	(a) FINDING.—Congress finds that a veteran who is
5	either a member of the Individual Ready Reserve, an Indi-
6	vidual Mobilization Augmentee, or an inactive member of
7	the National Guard and is not assigned to a unit that
8	musters regularly and has an established support struc-
9	ture is less likely to be helped by existing suicide preven-
10	tion programs carried out by the Secretary of Defense and
11	the Secretary of Veterans Affairs.
12	(b) In General.—
13	(1) Suicide Prevention.—Chapter 55 of title
14	10, United States Code, is amended by adding after
15	section 1074l the following new section:
16	"§ 1074m. Suicide prevention for members of the In-
17	dividual Ready Reserve, individual mobi-
18	lization augmentees, and inactive mem-
19	bers of the National Guard
20	"(a) In General.—The Secretary of Defense shall
21	ensure that each covered member receives a telephone call
22	described in subsection (b) not less than once every 90
23	days during the period in which—
24	"(1) the covered member is a member of the In-
25	dividual Ready Reserve;

- 1 "(2) the Secretary determines that the covered
- 2 member is an individual mobilization augmentee; or
- 3 "(3) the covered member is a member of the in-
- 4 active National Guard.
- 5 "(b) Counseling Call.—A telephone call described
- 6 in this subsection is a call from properly trained personnel
- 7 to determine the emotional, psychological, medical, and ca-
- 8 reer needs and concerns of the covered member.
- 9 "(c) Referral.—(1) The personnel making a tele-
- 10 phone call described in subsection (b) shall refer a covered
- 11 member identified as being at-risk of self-caused harm to
- 12 the nearest military medical treatment facility, accredited
- 13 TRICARE provider, or other private provider in accord-
- 14 ance with paragraph (3) for immediate evaluation and
- 15 treatment by a qualified mental health care provider.
- 16 "(2) If a covered member is referred under paragraph
- 17 (1), the Secretary shall confirm that the member has re-
- 18 ceived the evaluation and any necessary treatment.
- 19 "(3) In carrying out paragraph (1), the Secretary
- 20 shall refer a covered member to a qualified private mental
- 21 health care provider if the Secretary determines that such
- 22 private provider will ensure that such member will receive
- 23 treatment and assistance without delay.

1	"(d) Reports.—Not later than January 31 of each
2	year, beginning in 2013, the Secretary shall submit to
3	Congress a report on—
4	"(1) the number of covered members who have
5	been referred for counseling or mental health treat-
6	ment under this section, as well as the health and
7	career status of such members; and
8	"(2) any resource, regulatory, or statutory
9	issues that may be impeding the counseling calls
10	under this section from reaching all covered mem-
11	bers.
12	"(e) Covered Member Defined.—In this section,
13	the term 'covered member' means—
14	"(1) a member of the Individual Ready Reserve
15	described in section 10144(b) of this title who has
16	deployed to Afghanistan or Iraq in support of a con-
17	tingency operation on or after September 11, 2001;
18	"(2) a member of a reserve component who the
19	Secretary determines is an individual mobilization
20	augmentee who has deployed to Afghanistan or Iraq
21	in support of a contingency operation on or after
22	September 11, 2001; or
23	"(3) a member of the inactive National Guard
24	who has deployed to Afghanistan or Iraq in support

1	of a contingency operation on or after September 11,
2	2001.''.
3	(2) CLERICAL AMENDMENT.—The table of sec-
4	tions at the beginning of such chapter is amended
5	by inserting after the item relating to section 1074l
6	the following new item:
	"1074m. Suicide prevention for members of the Individual Ready Reserve, individual mobilization augmentees, and inactive members of the National Guard.".
7	(c) GAO REPORT.—The Comptroller General of the
8	United States, in cooperation with the Secretary of De-
9	fense, shall submit to Congress a report on suicide among
10	covered members (as defined in section 1074m(e) of title
11	10, United States Code, as added by subsection (b)), in-
12	cluding how many such members who have separated from
13	service have committed suicide.
14	(d) Use of Peer Counseling.—Consistent with
15	the findings of the August 2010 report titled "The Final
16	Report of the Department of Defense Task Force on the
17	Prevention of Suicide by Members of the Armed Forces",
18	the Secretary of Defense shall develop, evaluate, and more
19	widely disseminate programs (including peer-to-peer coun-
20	seling) that promote—
21	(1) connectedness between members of the

Armed Forces and the family, peers, and the imme-

diate chain of command of the members; and

1	(2) suicide risk identification and response with
2	particular emphasis on members of the Reserve
3	Components.
