#### A BILL

To provide for the conveyance of parcels of land to Mantua, Box Elder County, Utah.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Box Elder Utah Land
- 5 Conveyance Act".
- 6 SEC. 2. CONVEYANCE OF CERTAIN LANDS TO MANTUA, BOX
- 7 ELDER, UTAH.
- 8 (a) Conveyance Required.—The Secretary of Ag-
- 9 riculture shall convey, without consideration, to the town
- 10 of Mantua, Utah (in this section referred to as the
- 11 "town"), all right, title, and interest of the United States
- 12 in and to parcels of National Forest System land in the
- 13 Wasatch-Cache National Forest in Box Elder County,
- 14 Utah, consisting of approximately 31.5 acres within sec-
- 15 tion 27, township 9 north, range 1 west, Salt Lake merid-
- 16 ian and labeled as parcels A, B, and C on the map entitled
- 17 "Box Elder Utah Land Conveyance Act" and dated July
- 18 14, 2008.
- 19 (b) SURVEY.—If necessary, the exact acreage and
- 20 legal description of the lands to be conveyed under sub-
- 21 section (a) shall be determined by a survey satisfactory
- 22 to the Secretary. The cost of the survey shall be borne
- 23 by the town.

- 1 (c) Use of Land.—As a condition of the conveyance
- 2 under subsection (a), the town shall use the land conveyed
- 3 under such subsection for public purposes.
- 4 (d) Reversionary Interest.—In the quitclaim
- 5 deed to the town prepared as part of the conveyance under
- 6 subsection (a), the Secretary shall provide that the land
- 7 conveyed to the town under such subsection shall revert
- 8 to the Secretary, at the election of the Secretary, if the
- 9 land is used for other than public purposes.
- 10 (e) Additional Terms and Conditions.—The
- 11 Secretary may require such additional terms and condi-
- 12 tions in connection with the conveyance authorized under
- 13 subsection (a) as the Secretary considers appropriate to
- 14 protect the interests of the United States.
