- 10 each amended by striking "section 215(f)(5), 215(f)(6),
- 11 or 215(f)(9)(B)" in subparagraphs (C) and (D)(i) and in-
- 12 serting "paragraph (5) or (6) of section 215(f)".

13 SEC. 4. EFFECTIVE DATE.

- 14 The amendments made by this Act shall apply with
- 15 respect to monthly insurance benefits payable under title
- 16 II of the Social Security Act for months after December
- 17 2011. Notwithstanding section 215(f) of the Social Secu-
- 18 rity Act, the Commissioner of Social Security shall adjust
- 19 primary insurance amounts to the extent necessary to take
- 20 into account the amendments made by section 3.
