## A BILL

To provide for nuclear weapons abolition and economic conversion in accordance with District of Columbia Initiative Measure Number 37 of 1992, while ensuring environmental restoration and clean-energy conversion.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Nuclear Weapons Abo-  
5 lition and Economic and Energy Conversion Act of 2011”.

1 **SEC. 2. REQUIREMENT FOR NUCLEAR WEAPONS ABOLI-**  
2 **TION AND ECONOMIC AND ENERGY CONVER-**  
3 **SION.**

4 (a) IN GENERAL.—The United States Government  
5 shall—

6 (1) by the date that is three years after the  
7 date of the enactment of this Act, provide leadership  
8 to negotiate a multilateral treaty or other inter-  
9 national agreement that provides for—

10 (A) the dismantlement and elimination of  
11 all nuclear weapons in every country by not  
12 later than 2020; and

13 (B) strict and effective international con-  
14 trol of such dismantlement and elimination;

15 (2) redirect resources that are being used for  
16 nuclear weapons programs to use—

17 (A) in converting all nuclear weapons in-  
18 dustry employees, processes, plants, and pro-  
19 grams smoothly to constructive, ecologically  
20 beneficial peacetime activities, including strict  
21 control of all fissile material and radioactive  
22 waste, during the period in which nuclear weap-  
23 ons must be dismantled and eliminated pursu-  
24 ant to the treaty or other international agree-  
25 ment described in paragraph (1); and

1 (B) in addressing human and infrastruc-  
2 ture needs, including development and deploy-  
3 ment of sustainable carbon-free and nuclear-  
4 free energy sources, health care, housing, edu-  
5 cation, agriculture, and environmental restora-  
6 tion, including long-term radioactive waste mon-  
7 itoring;

8 (3) undertake vigorous, good-faith efforts to  
9 eliminate war, armed conflict, and all military oper-  
10 ations; and

11 (4) actively promote policies to induce all other  
12 countries to join in the commitments described in  
13 this subsection to create a more peaceful and secure  
14 world.

15 (b) EFFECTIVE DATE.—Subsection (a)(2) shall take  
16 effect on the date on which the President certifies to Con-  
17 gress that all countries possessing nuclear weapons have—

18 (1) eliminated such weapons; or

19 (2) begun such elimination under established  
20 legal requirements comparable to those described in  
21 subsection (a).
