Mr. Matheson (for himself and Mr. Terry) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To provide pet owners the ability to receive a copy of veterinary prescriptions, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fairness to Pet Own-
- 5 ers Act of 2011".
- 6 SEC. 2. RULES ON VETERINARY PRESCRIPTIONS.
- 7 Not later than 180 days after the date of enactment
- 8 of this Act, the Federal Trade Commission shall promul-
- 9 gate rules in accordance with section 553 of title 5, United

1	States Code, that include the following requirements with
2	regard to veterinary prescriptions:
3	(1) In general.—A requirement that the pre-
4	scriber of an animal drug shall—
5	(A) whether or not requested by the pet
6	owner, provide to the pet owner a copy of the
7	veterinary prescription and a written disclosure
8	that the pet owner may fill the prescription
9	through the prescriber (if available), or through
10	another pharmacy determined by the pet owner;
11	and
12	(B) provide or verify the prescription by
13	electronic or other means consistent with appli-
14	cable State law, if requested by any person des-
15	ignated to act on behalf of the pet owner.
16	(2) Purchase, payment, and waiver.—A re-
17	quirement that the prescriber of an animal drug—
18	(A) may not—
19	(i) require purchase of the animal
20	drug for which the veterinary prescription
21	was written from the prescriber or from
22	another person as a condition of providing
23	a copy of the veterinary prescription or
24	verifying such prescription under para-
25	graph (1);

1	(ii) require payment in addition to, or
2	as part of, the fee for an examination and
3	evaluation as a condition of providing a
4	copy of the veterinary prescription or
5	verifying such prescription under para-
6	graph (1); or
7	(iii) require the pet owner to sign a
8	waiver or disclaim liability, or deliver to
9	the pet owner a notice waiving or dis-
10	claiming liability of the prescriber for the
11	accuracy of the veterinary prescription, as
12	a condition of providing a copy of such
13	prescription or verifying such prescription
14	under paragraph (1); and
15	(B) may require payment of fees for an ex-
16	amination and evaluation before providing a
17	veterinary prescription, but only if the pre-
18	scriber requires immediate payment in the case
19	of an examination that reveals no requirement
20	for an animal drug.

21 SEC. 3. ENFORCEMENT.

A violation of a rule prescribed pursuant to section 23 2 of this Act shall be treated as a violation of a rule defin-24 ing an unfair or deceptive act or practice prescribed under 25 section 18(a)(1)(B) of the Federal Trade Commission Act

- 1 (15 U.S.C. 57a(a)(1)(B)). The Federal Trade Commission
- 2 shall enforce this Act in the same manner, by the same
- 3 means, and with the same jurisdiction as though all appli-
- 4 cable terms and provisions of the Federal Trade Commis-
- 5 sion Act were incorporated into and made a part of this
- 6 Act.

7 SEC. 4. PRESCRIBER VERIFICATION AND STATE LAW.

- 8 Nothing in this Act shall preempt applicable State
- 9 law with regard to verification of a veterinary prescription.
- 10 SEC. 5. DEFINITIONS.
- 11 As used in this Act:
- 12 (1) Animal drug.—The term "animal drug"
- means a drug intended to be administered to an ani-
- mal that may not be dispensed without a prescrip-
- tion.
- 16 (2) Domesticated Household Animal.—The
- term "domesticated household animal" means a
- 18 companion animal permitted under applicable State
- and local law to be kept in a home for noncommer-
- cial purposes.
- 21 (3) Pet owner.—The term "pet owner"
- means the legal owner of a domesticated household
- animal or a person designated by such owner to
- present such animal to the prescriber for care.

- (4) PRESCRIBER.—The term "prescriber" means a health care practitioner who is licensed to practice veterinary medicine or other person permitted under State law to issue prescriptions for animal drugs.
 - (5) VETERINARY PRESCRIPTION.—The term "veterinary prescription" means a written, oral, or electronic order from a prescriber authorizing the dispensing of an animal drug for use by a domesticated household animal, issued in accordance with State and Federal law.
