## A BILL

To amend title 10, United States Code, to authorize advance appropriations for military personnel, reserve personnel, and National Guard personnel accounts of the Department of Defense, generally title I of the annual Department of Defense appropriations Act.

- 1 Be it enacted by the Senate and House of Representa-

1	SECTION 1. ADVANCE APPROPRIATIONS FOR DEPARTMENT
2	OF DEFENSE MILITARY PERSONNEL AC-
3	COUNTS.
4	(a) In General.—Chapter 9 of title 10, United
5	States Code, is amended by inserting after section 226 the
6	following new section:
7	"§ 227. Advance appropriations for Department of De-
8	fense military personnel accounts
9	"(a) Inclusion of Advance Appropriations.—
10	For each fiscal year, beginning with fiscal year 2012, dis-
11	cretionary new budget authority provided in an appropria-
12	tions Act for the military personnel accounts of the De-
13	partment shall—
14	"(1) be made available for that fiscal year; and
15	"(2) include, for each such account, advance
16	discretionary new budget authority that first be-
17	comes available for the first fiscal year after the
18	budget year.
19	"(b) Estimates Required.—The Secretary of De-
20	fense shall include in documents submitted to Congress
21	in support of the President's budget submitted pursuant
22	to section 1105 of title 31 detailed estimates of the funds
23	necessary for the military personnel accounts of the De-
24	partment for the fiscal year following the fiscal year for
25	which the budget is submitted.

- 1 "(c) Annual Report.—Not later than July 31 of
- 2 each year, the Secretary of Defense shall submit to Con-
- 3 gress an annual report on the sufficiency of the resources
- 4 of the Department of Defense for the next fiscal year be-
- 5 ginning after the date of the submittal of the report for
- 6 the provision of military pay and allowances for members
- 7 of the Army, Navy, Air Force, and Marine Corps, and the
- 8 reserve components thereof.
- 9 "(d) Military Personnel Accounts Defined.—
- 10 In this section, the term 'military personnel accounts of
- 11 the Department' mean the military personnel, reserve per-
- 12 sonnel, and National Guard personnel accounts of the De-
- 13 partment of Defense, generally title I of an annual De-
- 14 partment of Defense appropriations Act.".
- 15 (b) Clerical Amendment.—The table of sections
- 16 at the beginning of such chapter is amended by inserting
- 17 after the item relating to section 226 following new item:

"227. Advance appropriations for Department of Defense military personnel accounts.".
