A BILL

To permit certain current loans that would otherwise be treated as non-accrual loans as accrual loans for certain purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Common Sense Eco-
- 5 nomic Recovery Act of 2011".
- 6 SEC. 2. TREATMENT OF CERTAIN LOANS.
- 7 (a) In General.—For purposes of determining cap-
- 8 ital requirements or measuring capital of an insured de-

- 1 pository institution under section 38 of the Federal De-
- 2 posit Insurance Act (12 U.S.C. 1831o) or any other provi-
- 3 sion of law or regulatory guidance, an insured depository
- 4 institution that would otherwise be required to treat a loan
- 5 as a non-accrual loan may treat such loan as an accrual
- 6 loan, if—
- 7 (1) the loan is current;
- 8 (2) during the previous 6-month period, no
- 9 monthly payment on the loan has been more than 30
- days delinquent;
- 11 (3) the loan is an amortizing loan; and
- 12 (4) the payments being made on the loan are
- 13 not being funded through an interest reserve ac-
- 14 count.
- 15 (b) Equality of Treatment for Modified
- 16 Mortgage Loans.—Subsection (a) shall apply to modi-
- 17 fied mortgage loans, including those loans that meet the
- 18 criteria for troubled debt restructuring, to the same extent
- 19 as non-modified mortgage loans, as long as the modified
- 20 mortgage loans also meet the requirements under para-
- 21 graphs (1) through (4) of subsection (a).
- 22 (c) No Additional Adverse Treatment.—With
- 23 respect to a loan held by an insured depository institution
- 24 and treated as an accrual loan by reason of subsection
- 25 (a), an appropriate Federal banking agency may not im-

- 1 pose any additional accounting requirements on such insti-
- 2 tution with respect to such loan compared to the require-
- 3 ments that would otherwise have been placed on such in-
- 4 stitution with respect to such loan if such loan were not
- 5 being treated as an accrual loan by reason of subsection
- 6 (a), if the result of such additional requirement would ad-
- 7 versely impact the measurement of capital of the institu-
- 8 tion.

9 SEC. 3. STUDY.

- 10 (a) In General.—The Financial Stability Oversight
- 11 Council shall conduct a study of how best to prevent con-
- 12 tradictory guidance from being issued by appropriate Fed-
- 13 eral banking agencies to insured depository institutions
- 14 with respect to loan classifications and capital require-
- 15 ments.
- 16 (b) Report.—Not later than the end of the 60-day
- 17 period beginning on the date of the enactment of this Act,
- 18 the Financial Stability Oversight Council shall issue a re-
- 19 port to the Congress containing—
- 20 (1) all determinations and conclusions made by
- 21 the Council in carrying out the study required under
- subsection (a); and
- 23 (2) legislative recommendations that the Coun-
- 24 cil believe will prevent contradictory guidance from
- being issued by appropriate Federal banking agen-

- 1 cies to insured depository institutions with respect to
- 2 loan classifications and capital requirements.

3 SEC. 4. DEFINITIONS.

- 4 For purposes of this Act, the terms "appropriate
- 5 Federal banking agency" and "insured depository institu-
- 6 tion" shall have the meaning given those terms, respec-
- 7 tively, under section 3 of the Federal Deposit Insurance
- 8 Act (12 U.S.C. 1813).

9 SEC. 5. SUNSET.

- 10 Effective after the end of the 2-year period beginning
- 11 on the date of the enactment of this Act, this Act shall
- 12 cease to have any force or effect.
