A BILL

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. IMPLEMENTATION OF GAO REPORT TO RE-
- 4 DUCE DUPLICATION IN GOVERNMENT PRO-
- 5 GRAMS.
- 6 Notwithstanding any other provision of law, not later
- 7 than 150 days after the date of enactment of this Act,

- 1 the Director of the Office of Management and Budget
- 2 shall coordinate with the heads of the relevant department
- 3 and agencies to—
- 4 (1) use available administrative authority to
- 5 eliminate, consolidate, or streamline Government
- 6 programs and agencies with duplicative and overlap-
- 7 ping missions identified in the March 2011 Govern-
- 8 ment Accountability Office report to Congress enti-
- 9 tled "Opportunities to Reduce Potential Duplication
- in Government Programs, Save Tax Dollars, and
- 11 Enhance Revenue" (GAO-11-318SP) and apply the
- savings towards deficit reduction;
- 13 (2) identify and report to Congress any legisla-
- tive changes required to further eliminate, consoli-
- date, or streamline Government programs and agen-
- cies with duplicative and overlapping missions identi-
- fied in the March 2011 Government Accountability
- Office report to Congress entitled "Opportunities to

- 20 grams, Save Tax Dollars, and Enhance Revenue"

- 22 (3) determine the total cost savings that shall
- result to each agency, office, and department from
