3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Citizens Right to Know

5 Act of 2011".

6 SEC. 2. REPORTING REQUIREMENTS.

- 7 (a) MONTHLY REPORT ON AGENCY OPERATIONS.—
- 8 Not later than the last day of each month, a State or local

1	pretrial services agency that receives Federal financial as-
2	sistance shall submit to the Attorney General a report that
3	includes the following:
4	(1) The number of individuals reviewed for pre-
5	trial release by that agency during the reporting pe-
6	riod.
7	(2) The number of indigent individuals reviewed
8	for pretrial release by that agency during the report-
9	ing period.
10	(3) The number of individuals assigned to pre-
11	trial services by that agency during the reporting pe-
12	riod, and the name of each such individual.
13	(4) The number of indigent individuals accepted
14	into a pretrial release program by that agency dur-
15	ing the reporting period, and the name of each such
16	individual.
17	(5) A list of each charge filed against each indi-
18	vidual accepted into a pretrial release program by
19	that agency during the reporting period.
20	(6) A list of all prior criminal convictions of
21	each individual accepted into a pretrial release pro-
22	gram by that agency during the reporting period.
23	(7) A list of the court appearances required of
24	each individual accepted into a pretrial release pro-
25	gram by that agency during the reporting period.

(8) A list of each instance during the reporting
 period on which an individual accepted into a pre trial release program by that agency failed to appear
 at a scheduled court appearance.

5 (9) A list of all warrants issued or arrests made 6 during the reporting period of each individual ac-7 cepted into a pretrial release program by that agen-8 cy.

9 (b) ANNUAL REPORT ON AGENCY BUDGET.—Not 10 later than the last day of the fiscal year in which this Act 11 is enacted, and annually thereafter, a State or local pre-12 trial services agency that receives Federal financial assist-13 ance shall submit to the Attorney General a report that 14 contains information on that agency's budget for that 15 year.

16 SEC. 3. DEFINITIONS.

17 In this Act:

(1) The term "State or local pretrial services
agency" means any government entity which provides pretrial services or any private non-profit entity contracted with to do the same.

(2) The term "Federal financial assistance" has
the meaning given such term in section 7501(a)(5)
of title 31, United States Code.
