A BILL

To amend title I of the Omnibus Crime Control and Safe Streets Act of 1968 to provide for improvements under the Edward Byrne Memorial Justice Assistance Grant Program to reduce racial and ethnic disparities in the criminal justice system.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Byrne/JAG Program
- 5 Accountability Act".

1	SEC. 2. IMPROVEMENTS UNDER THE EDWARD BYRNE ME-
2	MORIAL JUSTICE ASSISTANCE GRANT PRO-
3	GRAM TO REDUCE RACIAL AND ETHNIC DIS-
4	PARITIES IN THE CRIMINAL JUSTICE SYS-
5	TEM.
6	Section 501 of the Omnibus Crime Control and Safe
7	Streets Act of 1968 (42 U.S.C. 3751) is amended by add-
8	ing at the end the following new subsection:
9	"(h) Racial Disparities Practices.—For years
10	beginning after the date of the enactment of the Byrne/
11	JAG Program Accountability Act, States and units of
12	local government receiving funds under this subpart shall
13	implement policy, practice, and system improvement strat-
14	egies at the State, local, and tribal levels, as applicable,
15	to identify and reduce racial and ethnic disparities among
16	individuals who come into contact with or are under the
17	supervision of the criminal justice system, without estab-
18	lishing or requiring numerical standards or quotas,
19	through each of the following methods:
20	"(1) Establishing coordinating bodies, com-
21	posed of criminal justice stakeholders at the State,
22	local, or tribal levels, as applicable, to oversee and
23	monitor efforts by such States, unit of local govern-
24	ment, or Indian tribe to reduce racial and ethnic dis-

- "(2) Identifying and analyzing key decision points in the criminal justice system of the State, unit of local government, or Indian tribe, as applicable, to determine which points create racial and ethnic disparities among those who come into contact with the justice system.
 - "(3) Developing and implementing data collection and analysis systems to identify where racial and ethnic disparities exist in the criminal justice system and to track and analyze such disparities.
 - "(4) Developing and implementing a work plan that includes measurable objectives for policy practice or other system changes, based on the needs identified in the data collection and analysis under paragraphs (2) and (3).
 - "(5) Publicly reporting, on an annual basis, the efforts made in accordance with paragraphs (2), (3), and (4) during the previous year.".
