- 4 This Act may be cited as the "Protect America's En-
- 5 ergy and Manufacturing Jobs Act of 2011".

1 SEC. 2. SUSPENSION OF CERTAIN EPA ACTION.

- 2 (a) In General.—Except as provided in subsection
- 3 (b), notwithstanding any provision of the Clean Air Act
- 4 (42 U.S.C. 7401 et seq.), during the 2-year period begin-
- 5 ning on the date of enactment of this Act, the Adminis-
- 6 trator of the Environmental Protection Agency may not
- 7 take any action under the Clean Air Act (42 U.S.C. 7401
- 8 et seq.) with respect to any stationary source permitting
- 9 requirement or any requirement under section 111 of that

- 12 (b) Exceptions.—Subsection (a) shall not apply

- 14 (1) any action relating to the preparation of a
- 15 report or the enforcement of a reporting require-

- 17 (2) any action relating to the provision of tech-
- nical support at the request of a State.
- 19 (c) Treatment.—Notwithstanding any other provi-
- 20 sion of law, no action taken by the Administrator of the
- 21 Environmental Protection Agency before the end of the
- 22 2-year period described in subsection (a) (including any
- 23 such action before the date of the enactment of this Act)
- 24 shall be considered to make carbon dioxide or methane a
