4 This Act may be cited as the "Border States Security

5 Improvement Act".

1SEC. 2. DEPARTMENT OF DEFENSE FUNDING FOR STATE2BORDER SECURITY ACTIVITIES.

3 (a) SUPPORT FOR BORDER ACTIVITIES.—Section
4 902 of title 32, United States Code, is amended to read

6 "§ 902. Department of Defense support for National 7 Guard homeland defense activities and 8 State border security activities

9 "(a) HOMELAND DEFENSE ACTIVITIES.—The Sec-10 retary of Defense may provide funds to the Governor of 11 a State to employ units or members of the National Guard 12 of that State to conduct homeland defense activities that 13 the Secretary determines to be necessary and appropriate 14 for participation by the National Guard units or members.

15 "(b) BORDER SECURITY ACTIVITIES.—The Secretary 16 of Defense shall provide funds to the Governor of a State to employ units or members of the National Guard of that 17 State, State defense forces of that State, and law enforce-18 19 ment agencies of that State to help secure an international border that forms part of the border of that State if the 2021 Governor determines that their participation in border se-22 curity activities is necessary and appropriate. In the case 23 of the use of the National Guard, the Secretary shall pro-24 vide the requested funds even though the border security activities are conducted while the members of the National 25 Guard are not in Federal service.". 26
