A BILL

To offset the economic burden on border sheriffs from the lack of southern border security, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Southern Border Sher-
- 5 iffs Community Impact Aid Act of 2011".
- 6 SEC. 2. FINDINGS; SENSE OF CONGRESS.
- 7 (a) FINDINGS.—Congress finds the following:

- 1 (1) The international border of the United 2 States constitutes Federal infrastructure that has a 3 substantial economic impact on adjacent counties.
- 4 (2) The high level of documented illegal activity 5 on the United States southern border has placed a 6 unique economic burden on border sheriffs' depart-7 ments.
- 8 (b) Sense of Congress.—It is the sense of Con-
- 9 gress that the Federal Government should offset the addi-
- 10 tional law enforcement costs on these counties in a similar
- 11 manner to the Community Impact Aid program for local
- 12 schools that incur additional costs from Federal infra-
- 13 structure.

14 SEC. 3. COMMUNITY IMPACT AID GRANTS.

- 15 (a) In General.—The Secretary of Homeland Secu-
- 16 rity shall make grants to sheriffs' departments along the
- 17 southern border of the United States for the purpose of
- 18 hiring additional deputies, including for salaries, benefits,
- 19 training, uniforms, patrol vehicles, and arms.
- 20 (b) Grant Calculation Formula.—Except as
- 21 provided in subsection (c), a grant made pursuant to sub-
- 22 section (a) shall be in an amount equal to 30 percent of
- 23 an eligible sheriff's department's fiscal year 2010 budget
- 24 for patrol deputies.

- 1 (c) MINIMUM BENEFIT.—Notwithstanding the cal-
- 2 culation provided for in subsection (b), a grant made pur-
- 3 suant to subsection (a) to an eligible sheriff's department
- 4 shall be in an amount that allows for the hiring of at least
- 5 one additional deputy.
- 6 (d) Availability.—Grants made pursuant to sub-
- 7 section (a) are authorized to remain available until ex-
- 8 pended.
- 9 (e) Eligibility and Funding.—To be eligible to re-
- 10 ceive a grant under this section, a sheriff's department
- 11 shall submit to the Secretary of Homeland Security an ap-
- 12 plication at such time, in such manner, and containing
- 13 such information as the Secretary may require.
- 14 (f) Eligible Sheriffs' Departments.—Sheriffs'
- 15 departments in the following counties are eligible to re-
- 16 ceive grants under this section:
- 17 (1) In Texas, the following counties: El Paso,
- 18 Hudspeth, Culberson, Jeff Davis, Presidio, Brew-
- 19 ster, Terrell, Val Verde, Kinney, Maverick, Dimmit,
- Webb, Zapata, Starr, Hidalgo, Cameron, Willacy,
- 21 Jim Hogg, Zavala, and Pecos Counties.
- 22 (2) In Arizona, the following counties: Yuma,
- Pima, Santa Cruz, and Cochise Counties.

1	(3) In New Mexico, the following counties
2	Dona Ana, Luna, Grant, Otero, and Hidalgo Coun-
3	ties.
4	(4) In California, the following counties: San
5	Diego and Imperial Counties.
6	(g) Cut as You Go.—To carry out this section, the
7	Secretary of Homeland Security shall reprogram funds
8	that would otherwise be obligated and expended under the
9	account heading "Departmental Management and Oper-
