(1) IN GENERAL.—Subchapter III of chapter
 33 of title 38, United States Code, is amended by
 adding at the end the following new section:

### 4 "§ 3325. Reporting requirement

5 "(a) IN GENERAL.—The Secretary of Defense and 6 the Secretary shall submit to the Congress at least once 7 every year separate reports on the operation of the pro-8 gram provided for in this chapter.

9 "(b) CONTENTS OF SECRETARY OF DEFENSE RE10 PORTS.—The Secretary of Defense shall include in each
11 report submitted under this section—

12 "(1) information indicating—

13 "(A) the extent to which the benefit levels 14 provided under this chapter are adequate to 15 achieve the purposes of inducing individuals to 16 enter and remain in the Armed Forces and of 17 providing an adequate level of financial assist-18 ance to help meet the cost of pursuing a pro-19 gram of education;

20 "(B) whether it is necessary for the pur21 poses of maintaining adequate levels of well22 qualified active-duty personnel in the Armed
23 Forces to continue to offer the opportunity for
24 educational assistance under this chapter to in-

1 dividuals who have not yet entered active-duty 2 service; and 3 "(C) describing the efforts under section 4 3323(b) of this title to inform members of the 5 Armed Forces of the active duty service require-6 ments for entitlement to educational assistance 7 benefits under this chapter and the results from 8 such efforts; and 9 "(2) such recommendations for administrative 10 and legislative changes regarding the provision of 11 educational assistance to members of the Armed 12 Forces and veterans, and their dependents, as the 13 Secretary of Defense considers appropriate. 14 "(c) CONTENTS OF SECRETARY OF VETERANS AF-15 FAIRS REPORTS.—The Secretary shall include in each report submitted under this section— 16 17 "(1) information concerning the level of utiliza-18 tion of educational assistance and of expenditures 19 under this chapter; 20 "(2) the number of credit hours, certificates, 21 degrees, and other qualifications earned by bene-22 ficiaries under this chapter during the fiscal year 23 preceding the fiscal year during which the report is 24 submitted; and
