A BILL

To prohibit the awarding of Federal grants and contracts to 4-year institutions of higher education that fail to offer academic credit for the successful completion of courses offered by a Senior Reserve Officers' Training Corps program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Eliminating Disincen-
- 5 tives to ROTC Participation Act".

1	SEC. 2. PROHIBITION OF FEDERAL GRANTS AND CON-
2	TRACTS.
3	(a) Grant and Contract Eligibility.—Notwith-
4	standing any other provision of law, no 4-year institution
5	of higher education (as defined in section 102 of the High-
6	er Education Act of 1965 (20 U.S.C. 1002)) shall be eligi-
7	ble to be awarded, or to continue to receive funds for per-
8	formance under, a Federal grant or contract, unless such
9	institution provides a certification described in subsection
0	(b) to the head of the Federal agency or department ad-
1	ministering such grant or contract—
2	(1) for the purpose of being eligible to be
3	awarded a grant or contract, at the time such insti-
4	tution submits an application for such grant or con-
5	tract; or
6	(2) for the purpose of being eligible to continue
7	to receive funds for performance under a grant or
8	contract, not later than January 31, 2012.
9	(b) Certification.—To comply with subsection (a),
20	an institution shall certify that it offers not fewer than
21	6 credit hours to students enrolled in the institution for
22	the successful completion of courses offered by a Senior
23	Reserve Officers' Training Corps program established
24	under section 2102 of title 10, United States Code, with-
25	out regard to whether the courses were completed at the

26 institution.

1	(c) Effective Date.—This section shall—
2	(1) take effect on October 1, 2011; and
3	(2) apply to an institution of higher education's
4	eligibility—
5	(A) to be awarded a grant or contract on
6	or after October 1, 2011; and
7	(B) to continue to receive funds for per-
8	formance under a grant or contract awarded
9	before October 1, 2011.
