A BILL

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

SECTION 1. REDUCTION IN PAY FOR MEMBERS OF CON-

- GRESS.
- 3 (a) REDUCTION.—Notwithstanding any other provi-
- 4 sion of law, the annual rate of pay for each Member of
- 5 Congress shall be as follows:
- 6 (1) For pay periods during the period beginning
- 7 October 1, 2011, and ending December 31, 2012,
- 8 the applicable rate in effect as of the date of the en-
- 9 actment of this Act.
- 10 (2) For pay periods occurring during 2013, the
- applicable rate during the period described in para-
- graph (1) reduced by 10 percent, rounded to the
- nearest multiple of \$100 (or, if midway between
- multiples of \$100, to the next higher multiple of
- 15 \$100).
- 16 (3) For subsequent pay periods, the applicable
- 17 rate during 2013, subject to adjustment under para-
- graph (2) of section 601(a) of the Legislative Reor-
- 19 ganization Act of 1946 (2 U.S.C. 31(2)).
- 20 (b) Member of Congress Defined.—For pur-
- 21 poses of this section, the term "Member of Congress"
- 22 means an individual serving in a position under subpara-
- 23 graph (A), (B), or (C) of section 601(a) of the Legislative
- 24 Reorganization Act of 1946 (2 U.S.C. 31).

7 SEC. 3. REDUCTION IN SALARIES AND EXPENSES FOR LEG-

- 8 ISLATIVE BRANCH OFFICES.
- 9 (a) REDUCTION.—The aggregate amount which may
- 10 be appropriated or otherwise made available for fiscal year
- 11 2012 for allowances and expenses (including salaries) of
- 12 any office of the legislative branch may not exceed 96%
- 13 of the aggregate amount appropriated or otherwise made
- 14 available for fiscal year 2011 for allowances and expenses
- 15 of such office.
- 16 (b) Exception for Capitol Police.—Subsection
- 17 (a) does not apply with respect to the United States Cap-
- 18 itol Police.
