# A BILL

To amend the Budget Control Act of 2011 to protect the Medicare program from budget cuts under such Act.

### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Medicare Protection

5 Act of 2011".

### 6 SEC. 2. NO MEDICARE CUTS.

7 (a) NO CUTS THROUGH LEGISLATIVE LANGUAGE OF

8 THE JOINT SELECT COMMITTEE.—

(1) IN GENERAL.—Title IV of the Budget Con trol Act of 2011 is amended by adding at the end
 the following new section:

### 4 "SEC. 405. NO MEDICARE CUTS.

5 "(a) IN GENERAL.—The joint committee shall not in6 clude in its proposed legislative language submitted pursu7 ant to section 401(b)(3)(B)(iv) any provision that reduces
8 eligibility, payments, or benefits, increases premiums or
9 other cost-sharing, or otherwise reduces outlays under the
10 Medicare program under title XVIII of the Social Security
11 Act.

12 "(b) NO APPLICATION OF EXPEDITED PROCE-13 DURES.—If the joint committee bill includes a provision 14 that violates subsection (a), the expedited procedures in 15 section 402 shall not apply to such bill.".

16 (2) CLERICAL AMENDMENT.—The table of con17 tents in section 1(b) of such Act is amended by in18 serting after the item relating to section 404 the fol19 lowing new item:

"Sec. 405. No Medicare cuts.".

(b) NO CUTS THROUGH FALLBACK SEQUESTRATION
PROCESS.—Section 251A(8) of the Balanced Budget and
Emergency Deficit Control Act of 1985, as inserted by
section 302(a) of the Budget Control Act of 2011, is
amended by striking "except that the percentage reduction
for the Medicare programs specified in section 256(d)
HR 2725 IH

shall not be more than 2 percent for a fiscal year" and
 inserting "except that there shall be no percentage reduc tion for the Medicare programs specified in section 256(d)
 for any fiscal year and in no case shall there be a reduction
 under such programs pursuant to a sequestration under
 section 3101A(f)(6) of title 31, United States Code".
