8 THE JOINT SELECT COMMITTEE.

1 (1) IN GENERAL.—Title IV of the Budget Con-2 trol Act of 2011 is amended by adding at the end 3 the following new section: 4 "SEC. 405. NO EDUCATION CUTS. 5 "(a) IN GENERAL.—The joint committee shall not include in its proposed legislative language submitted pursu-6 7 ant to section 401(b)(3)(B)(iv) any provision that reduces 8 eligibility, payments, or benefits, or otherwise reduces out-9 lays or budget authority under— 10 "(1) the Head Start Act (42 U.S.C. 9801 et 11 seq.); or "(2) any program administered by the Sec-12 13 retary of Education, including any program under— "(A) the Elementary and Secondary Edu-14 15 cation Act of 1965 (20 U.S.C. 6301 et seq.); "(B) the Individuals with Disabilities Edu-16 17 cation Act (20 U.S.C. 1400 et seq.); 18 "(C) the Higher Education Act of 1965 19 (20 U.S.C. 1001 et seq.); or 20 "(D) the Rehabilitation Act of 1973 (29 21 U.S.C. 701 et seq.). 22 "(b) NO APPLICATION OF EXPEDITED PROCE-23 DURES.—If the joint committee bill includes a provision 24 that violates subsection (a), the expedited procedures in section 402 shall not apply to such bill.". 25

11 "(12) NO CUTS FOR EDUCATION.—Notwith-12 standing any other provision of law, no sequestration order issued under this section or section 3101A of 13 14 title 31, United States Code, or discretionary spend-15 ing limit made under this section shall reduce eligi-16 bility, payments, or benefits under any Act or pro-17 gram referred to in section 405(a) of the Budget 18 Control Act of 2011.".
