## A BILL

To prohibit offices of the legislative branch from entering into a contract for the provision of goods or services within the Capitol Complex with any contractor who does not participate in the E-Verify Program for employment eligibility verification, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Secure the Capitol
- 5 Act''.

### SEC. 2. REQUIRING LEGISLATIVE BRANCH CONTRACTORS 2 TO PARTICIPATE IN E-VERIFY PROGRAM. 3 An office of the legislative branch may not enter into a contract for the provision of goods or services within 4 5 the Capitol Complex with any contractor who employs individuals unless the contractor— 6 7 (1) elects to participate in the E-Verify Pro-8 gram described in section 403(a) of the Illegal Im-9 migration Reform and Immigrant Responsibility Act 10 of 1996 (8 U.S.C. 1324a note), and is in compliance 11 with the terms and conditions of such election, with 12 respect to all of its employees as well as those pro-13 viding goods or services under the contract; and 14 (2) certifies that each of its subcontractors pro-15 viding goods or services under the contract has elect-16 ed to participate in such program, and is in compli-17 ance with the terms and conditions of such election, 18 with respect to all of its employees as well as those 19 providing goods or services under the subcontract. 20 SEC. 3. CAPITOL COMPLEX DEFINED. 21 For purposes of this Act, the "Capitol Complex" con-22 sists of the following facilities together with their grounds: 23 (1) The United States Capitol (including the 24 Capitol Visitor Center) and the Capitol Grounds. 25 (2) The Cannon, Longworth, Rayburn, and

13	SEC. 4. EFFECTIVE DATE; TRANSITION FOR CURRENT CON-
14	TRACTS.
15	(a) In General.—This Act shall apply with respect
16	to contracts entered into after the expiration of the 30-
17	day period which begins on the date of the enactment of
18	this Act.
19	(b) Transition for Current Contracts.—Upon
20	the enactment of this Act, each office of the legislative
21	branch with a contract in effect on the date of the enact-
22	ment of this Act which is described in section 2 shall ob-
23	tain assurances from the contractor involved that the con-

- 2 to the expiration of the period described in subsection (a).
