3	SECTION 1. SHORT TITLE.			
4	This Act may be cited as the "Piracy Suppression			
5	Act of 2011".			
6	SEC. 2. ACT OF PIRACY.			
7	Section 4297 of the Revised Statutes of the United			
8	States (33 U.S.C. 385) is amended by striking so much			
9	as precedes the text and inserting the following:

11 SEC. 5. SECURITY OF GOVERNMENT IMPELLED CARGO.

- 12 Section 55305 of title 46, United States Code, is
- 13 amended by adding at the end the following new sub-

- 15 "(e) Security of Government Impelled

- "(1) In order to assure the safety of vessels and
- 18 crewmembers transporting equipment, materials, or

- "(2) The Secretary of Transportation shall direct each such department or agency to reimburse, subject to the availability or appropriations, the owners or operators of such vessels for the cost of providing armed personnel.
- 6 "(3) For the purposes of this subsection, the 7 term 'high-risk waters' means waters so designated 8 by the Commandant of the Coast Guard in the Port 9 Security Advisory in effect on the date on which the 10 voyage begins.".

11 SEC. 6. GAO STUDY.

- Not later than 1 year after the date of enactment
- 13 of this Act, the Comptroller General of the United States
- 14 shall report to the Committee on Transportation and In-
- 15 frastructure of the House of Representatives and the Com-
- 16 mittee on Commerce, Science, and Transportation of the
- 17 Senate on efforts to track ransom payments paid to pi-
- 18 rates operating in the waters off Somalia and improve the
- 19 prosecution of such pirates. The report shall include—
- 20 (1) the status of Working Group 5 of the Con-
- 21 tact Group on Piracy Off the Somali Coast, any ef-
- forts undertaken by the Working Group, and rec-
- ommendations for improving the Working Group's
- 24 effectiveness;

- 1 (2) efforts undertaken by the United States 2 Government to implement and enforce Executive 3 Order 13536, including recommendations on how to 4 better implement that order to suppress piracy;
 - (3) efforts undertaken by the United States Government to track ransom payments made to pirates operating off the coast of Somalia, the effectiveness of those efforts, any operational actions taken based off those efforts, and recommendations on how to improve such tracking;
 - (4) actions taken by the United States Government to improve the international prosecution of pirates captured off the coast of Somalia; and
 - (5) an update on the United States Government's efforts to implement the recommendation contained in General Accountability Office report GAO-10-856, entitled "Maritime Security: Actions Needed to Assess and Update Plan and Enhance Collaboration among Partners Involved in Countering Piracy off the Horn of Africa", that metrics should be established for measuring the effectiveness of counter piracy efforts.
