## A BILL

To amend the Horse Protection Act to prohibit the shipping, transporting, moving, delivering, receiving, possessing, purchasing, selling, or donation of horses and other equines to be slaughtered for human consumption, and for other purposes.

1 Be it enacted by the Senate and House of Representa-2 tives of the United States of America in Congress assembled, SECTION 1. SHORT TITLE. 3 This Act may be cited as the "American Horse 4 5 Slaughter Prevention Act of 2011". SEC. 2. PROHIBITION ON SHIPPING, TRANSPORTING, MOV-6 7 ING, DELIVERING, RECEIVING, POSSESSING, 8 PURCHASING, SELLING, OR DONATION OF 9 HORSES AND OTHER EQUINES FOR SLAUGH-10 TER FOR HUMAN CONSUMPTION. 11 (a) DEFINITIONS.—Section 2 of the Horse Protection 12 Act (15 U.S.C. 1821) is amended— 13 (1) by redesignating paragraphs (1), (2), (3), 14 and (4) as paragraphs (2), (3), (5), and (6), respec-15 tively; 16 (2) by inserting before paragraph (2) (as redes-17 ignated by paragraph (1)) the following: 18 "(1) The term 'human consumption' means in-19 gestion by people as a source of food."; and 20 (3) by inserting after paragraph (3) (as redesig-21 nated by paragraph (1)) the following: 22 "(4) The term 'slaughter' means the killing of 1 or more horses or other equines with the intent to 23 24 sell or trade the flesh for human consumption.". •HR 2966 IH

(d) AUTHORITY TO DETAIN.—Section 6(e) of the 19 20 Horse Protection Act (15 U.S.C. 1825(e)) is amended— 21 (1) by striking the first sentence of paragraph 22 (1);

14	(e) Authorization of Appropriations.—Section
