A BILL

To amend the Fair Housing Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Housing Opportunities
- 5 Made Equal Act of 2011" or the "HOME Act of 2011".
- 6 SEC. 2. AMENDING THE FAIR HOUSING ACT TO PROHIBIT

3	SEC. 3. AMENDING THE FAIR HOUSING ACT TO EXTEND
4	THE DEFINITION OF DISCRIMINATORY HOUS-

14	SEC. 4. AMENDING THE FAIR HOUSING ACT DEFINITION OF
15	"FAMILIAL STATUS".
16	Section 802(k) of the Fair Housing Act (42 U.S.C.

- 2 basis of familial status apply to any person who is preg-
- 3 nant or in the process of securing legal custody of an indi-
- 4 vidual who has not attained the age of 18 years.".
