A BILL

To partially waive the renewable fuel standard when corn inventories are low.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Renewable Fuel Stand-
- 5 ard Flexibility Act".

1 SEC. 2. PARTIAL WAIVER.

2	Paragraph (7) of section 211(o) of the Clean Air Act
3	(42 U.S.C. 7545(o)(7)) is amended by adding the fol-
4	lowing at the end thereof:
5	"(G) Consideration of corn inven-
6	TORIES.—
7	"(i) Determinations regarding
8	CORN STOCKS-TO-USE RATIO.—Not later
9	than August 1 and the end of November
10	each year, the Administrator shall deter-
11	mine and publish the United States corn
12	stocks-to-use ratio for the current crop
13	year—
14	"(I) in consultation with the Sec-
15	retary of Agriculture; and
16	"(II) based on the most recent
17	publication of the World Agricultural
18	Supply and Demand Estimate or
19	other similar authoritative estimate
20	issued by the Secretary of Agriculture.
21	"(ii) Waiver.—Based on the Admin-
22	istrator's most recent determination under
23	clause (i), the Administrator shall waive
24	the requirements of paragraph (2) by re-
25	ducing the national quantity of renewable

fuel otherwise required for a period in accordance with the following table:

"U.S. Corn Stocks-to-Use Ratio for the Current Crop Year (percent)	Reduction in national quantity of renewable fuel required
Above 10.0	No adjustment
10.0-7.5	10 percent reduction
7.49-6.0	15 percent reduction
5.99-5.0	25 percent reduction
Below 5.0	50 percent reduction.

3 "(iii) Duration.—A waiver granted 4 under clause (ii)— "(I) based on a determination re-5 6 quired by clause (i) to be made by the 7 end of November, shall be effective for 8 the following calendar year; and 9 "(II) based on a determination required by clause (i) to be made by 10 11 August 1, shall take effect 30 days 12 from the date of publication of the de-13 termination and shall (in place of the 14 waiver under subclause (I)) be effec-15 tive for the remainder of such cal-16 endar year. 17 "(iv) Adjustment of Renewable FUEL OBLIGATION.—Upon granting any 18 19 waiver under clause (ii) reducing the na-20 tional quantity of renewable fuel required 21 for a period to which paragraph (3) ap-

1	plies, the Administrator shall adjust the re-
2	newable fuel obligation determined under
3	paragraph (3) in proportion to such reduc-
4	tion.
5	"(v) No effect on required vol-
6	UME OF ADVANCED BIOFUEL.—A waiver
7	granted under this subparagraph reducing
8	the national quantity of renewable fuel re-
9	quired for a period shall not affect the vol-
10	ume of advanced biofuel required under
11	paragraph (2). The Administrator shall not
12	allow any volume of conventional biofuel to
13	be used to satisfy the requirement for ad-
14	vanced biofuel under paragraph (2).
15	"(vi) Publication.—The Adminis-
16	trator shall publish each waiver under
17	clause (ii) in the Federal Register, includ-
18	ing an explanation of the basis for the
