## 1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Port Security Effi-
3	ciency Act''.
4	SEC. 2. RECOGNITION OF PORT SECURITY ASSESSMENTS
5	CONDUCTED BY OTHER ENTITIES.
6	Section 70108 of title 46, United States Code, is
7	amended by adding at the end the following new sub-
8	section:
9	"(f) Recognition of Assessment Conducted by
10	OTHER ENTITIES.—
11	"(1) CERTIFICATION AND TREATMENT OF AS-
12	SESSMENTS.—For the purposes of this section and
13	section 70109, the Secretary may treat an assess-
14	ment conducted by a foreign government or inter-
15	national organization as an assessment by the Sec-
16	retary required by subsection (a), if the Secretary
17	certifies that the assessment was conducted in ac-
18	cordance with subsection (b).
19	"(2) Authorization to enter into agree-
20	MENTS.—The Secretary may enter into agreements
21	with a foreign government or international organiza-
22	tion, under which—
23	"(A) such government or organization
24	may, on behalf of the Secretary, conduct an as-
25	sessment required under subsection (a), or

1	share with the Secretary information pertaining
2	to such assessments; and
3	"(B) the Secretary may, on behalf of such
4	foreign government or organization, conduct an
5	assessment described in subsection (a), or share
6	with such foreign government or organization
7	information pertaining to such assessments.
8	"(3) Limitations.—
9	"(A) Nothing in this subsection—
10	"(i) requires the Secretary to recog-
11	nize an assessment that a foreign govern-
12	ment or an international organization con-
13	ducts pursuant to this subsection; or
14	"(ii) limits the discretion or ability of
15	the Secretary to conduct an assessment
16	under this section.
17	"(B) The Secretary may not delegate the
18	authority of the Secretary under this subsection
19	to any other officer of the department in which
20	the Coast Guard is operating"
