AN ACT

- To establish the position of Special Assistant for Veterans Affairs in the Department of Housing and Urban Development, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Homes for Heroes Act3 of 2012".

4 SEC. 2. SPECIAL ASSISTANT FOR VETERANS AFFAIRS IN
5 THE DEPARTMENT OF HOUSING AND URBAN
6 DEVELOPMENT.

7 Section 4 of the Department of Housing and Urban
8 Development Act (42 U.S.C. 3533) is amended by adding
9 at the end the following new subsection:

10 "(g) Special Assistant for Veterans Af-11 fairs.—

"(1) ESTABLISHMENT.—There shall be in the
Department a Special Assistant for Veterans Affairs, who shall be a special assistant to the Secretary and shall report directly to the Secretary.

16 "(2) APPOINTMENT.—The Special Assistant for
17 Veterans Affairs shall be appointed based solely on
18 merit and shall be covered under the provisions of
19 title 5, United States Code, governing appointments
20 in the competitive service.

21 "(3) RESPONSIBILITIES.—The Special Assist22 ant for Veterans Affairs shall be responsible for—

23 "(A) ensuring veterans have fair access to
24 housing and homeless assistance under each
25 program of the Department providing either
26 such assistance;

1	"(B) coordinating all programs and activi-
2	ties of the Department relating to veterans;
3	"(C) serving as a liaison for the Depart-
4	ment with the Department of Veterans Affairs,
5	including establishing and maintaining relation-
6	ships with the Secretary of Veterans Affairs;
7	"(D) serving as a liaison for the Depart-
8	ment, and establishing and maintaining rela-
9	tionships with the United States Interagency
10	Council on Homelessness and officials of State,
11	local, regional, and nongovernmental organiza-
12	tions concerned with veterans;
13	"(E) providing information and advice re-
14	garding-
15	"(i) sponsoring housing projects for
16	veterans assisted under programs adminis-
17	tered by the Department; or
18	"(ii) assisting veterans in obtaining
19	housing or homeless assistance under pro-
20	grams administered by the Department;
21	"(F) coordinating with the Secretary of
22	Housing and Urban Development and the Sec-
23	retary of Veterans Affairs in carrying out sec-
24	tion 3 of the Homes for Heroes Act of 2012;
25	and

"(G) carrying out such other duties as may
 be assigned to the Special Assistant by the Sec retary or by law.".

4 SEC. 3. ANNUAL SUPPLEMENTAL REPORT ON VETERANS 5 HOMELESSNESS.

6 (a) IN GENERAL.—The Secretary of Housing and 7 Urban Development and the Secretary of Veterans Af-8 fairs, in coordination with the United States Interagency 9 Council on Homelessness, shall submit annually to the 10 Committees of the Congress specified in subsection (b), 11 together with the annual reports required by such Secretaries under section 203(c)(1) of the McKinney-Vento 12 13 Homeless Assistance Act (42 U.S.C. 11313(c)(1)), a supplemental report that includes the following information 14 15 with respect to the preceding year:

- (1) The same information, for such preceding
 year, that was included with respect to 2010 in the
 report by the Secretary of Housing and Urban Development and the Secretary of Veterans Affairs entitled "Veterans Homelessness: A Supplemental Report to the 2010 Annual Homeless Assessment Report to Congress".
- (2) Information regarding the activities of theDepartment of Housing and Urban Development re-

lating to veterans during such preceding year, as fol lows:

3 (A) The number of veterans provided as-4 sistance under the housing choice voucher pro-5 gram for Veterans Affairs supported housing 6 (VASH) under section 8(0)(19) of the United 7 States Housing Act of 1937 (42)U.S.C. 8 1437f(o)(19), the socioeconomic characteristics 9 of such homeless veterans, and the number, 10 types, and locations of entities contracted under 11 such section to administer the vouchers.

12 (B) A summary description of the special 13 considerations made for veterans under public 14 housing agency plans submitted pursuant to 15 section 5A of the United States Housing Act of 16 1937 (42 U.S.C. 1437c-1) and under com-17 prehensive housing affordability strategies sub-18 mitted pursuant to section 105 of the Cranston-19 Gonzalez National Affordable Housing Act (42 20 U.S.C. 12705).

21 (C) A description of the activities of the
22 Special Assistant for Veterans Affairs of the
23 Department of Housing and Urban Develop24 ment.

1	(D) A description of the efforts of the De-
2	partment of Housing and Urban Development
3	and the other members of the United States
4	Interagency Council on Homelessness to coordi-
5	nate the delivery of housing and services to vet-
6	erans.
7	(E) The cost to the Department of Hous-
8	ing and Urban Development of administering
9	the programs and activities relating to veterans.
10	(F) Any other information that the Sec-
11	retary of Housing and Urban Development and
12	the Secretary of Veterans Affairs consider rel-
13	evant in assessing the programs and activities
14	of the Department of Housing and Urban De-
15	velopment relating to veterans.
16	(b) Committees.—The Committees of the Congress
17	specified in this subsection are as follows:
18	(1) The Committee on Banking, Housing, and
19	Urban Affairs of the Senate.
20	(2) The Committee on Veterans' Affairs of the
21	Senate.
22	(3) The Committee on Appropriations of the
23	Senate.
24	(4) The Committee on Financial Services of the
25	House of Representatives.

(5) The Committee on Veterans' Affairs of the
 House of Representatives.

3 (6) The Committee on Appropriations of the4 House of Representatives.
