A BILL

- To prohibit election officials from requiring individuals to provide photo identification as a condition of obtaining or casting a ballot in an election for Federal office or registering to vote in elections for Federal office, and for other purposes.

 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Voter Access Protec-
 - 5 tion Act of 2011".

1	SEC. 2. PROHIBITING STATES FROM IMPOSING PHOTO
2	IDENTIFICATION REQUIREMENT FOR VOTING
3	OR REGISTERING TO VOTE IN FEDERAL
4	ELECTIONS.
5	(a) Prohibition.—
6	(1) IN GENERAL.—Title III of the Help Amer-
7	ica Vote Act of 2002 (42 U.S.C. 15481 et seq.) is
8	amended by inserting after section 303 the following
9	new section:
10	"SEC. 303A. PROHIBITING ELECTION OFFICIALS FROM RE-
11	QUIRING INDIVIDUALS TO PRESENT PHOTO
12	IDENTIFICATION.
13	"(a) Photo Identification as a Condition of
14	Voting.—Except to the extent permitted under section
15	303(b), a State or local election official may not—
16	"(1) require an individual to present a photo
17	identification (or, in the case of an individual who
18	desires to vote by mail, a copy of a photo identifica-
19	tion) as a condition of obtaining or easting a ballot
20	in an election for Federal office; or
21	"(2) require an individual to cast a provisional
22	ballot under section 302 solely on the grounds that
23	the individual does not present a photo identification
24	at the polling place.
25	"(b) Photo Identification as a Condition of
26	REGISTERING TO VOTE.—A State or local election official

- 1 may not require an individual to provide a photo identi-
- 2 fication (or, in the case of an individual who desires to
- 3 register to vote by mail or online, a copy or electronic copy
- 4 of a photo identification) as a condition of registering to
- 5 vote in an election for Federal office.".
- 6 (2) CLERICAL AMENDMENT.—The table of con-
- 7 tents of such Act is amended by inserting after the
- 8 item relating to section 303 the following new item:

"Sec. 303A. Prohibiting election officials from requiring individuals to present photo identification.".

- 9 (b) Conforming Amendment Relating to En-
- 10 FORCEMENT.—Section 401 of such Act (42 U.S.C. 15511)
- 11 is amended by striking "and 303" and inserting "303, and
- 12 303A".
- 13 SEC. 3. EFFECTIVE DATE.
- 14 The amendments made by this Act shall apply with
- 15 respect to elections occurring after the date of the enact-
- 16 ment of this Act.
