## A BILL

To expand the Wild Rogue Wilderness Area in the State of Oregon, to make additional wild and scenic river designations in the Rogue River area, and to provide additional protections for Rogue River tributaries, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. EXPANSION OF WILD ROGUE WILDERNESS
- 4 AREA.
- 5 (a) Expansion.—In accordance with the Wilderness
- 6 Act (16 U.S.C. 1131 et seq.), certain Federal land man-
- 7 aged by the Bureau of Land Management, comprising ap-

proximately 58,100 acres, as generally depicted on the map entitled "Wild Rogue", dated September 16, 2010, 3 are hereby included in the Wild Rogue Wilderness, a com-4 ponent of the National Wilderness Preservation System. 5 (b) Maps and Legal Descriptions.— 6 (1) In General.—As soon as practicable after 7 the date of enactment of this Act, the Secretary of 8 the Interior shall file a map and a legal description 9 of the wilderness area designated by this section, with— 10 11 (A) the Committee on Energy and Natural 12 Resources of the Senate; and 13 (B) the Committee on Natural Resources 14 of the House of Representatives. 15 (2) Force of Law.—The maps and legal de-16 scriptions filed under paragraph (1) shall have the 17 same force and effect as if included in this subtitle, 18 except that the Secretary may correct typographical 19 errors in the maps and legal descriptions. 20 (3) Public availability.—Each map and 21 legal description filed under paragraph (1) shall be 22 on file and available for public inspection in the ap-23 propriate offices of the Bureau of Land Manage-

ment.

1	(e) Administration.—Subject to valid existing
2	rights, the area designated as wilderness by this section
3	shall be administered by the Secretary of the Interior in
4	accordance with the Wilderness Act (16 U.S.C. 1131 et
5	seq.).
6	(d) Withdrawal.—Subject to valid rights in exist-
7	ence on the date of enactment of this Act, the Federal
8	land designated as wilderness by this section is withdrawn
9	from all forms of—
10	(1) entry, appropriation, or disposal under the
11	public land laws;
12	(2) location, entry, and patent under the mining
13	laws; and
14	(3) disposition under all laws pertaining to min-
15	eral and geothermal leasing or mineral materials.
16	SEC. 2. WILD AND SCENIC RIVER DESIGNATIONS, ROGUE
17	RIVER AREA.
18	(a) Amendments.—Section 3(a)(5) of the Wild and
19	Scenic Rivers Act (16 U.S.C. 1274(a)(5)) (relating to the
20	Rogue River, Oregon) is amended by adding at the end
21	the following:
22	"In addition to the segment described in the
23	previous sentence, the following segments in the
24	Rogue River area are designated:

1	"(A) Kelsey creek.—The approximately
2	4.8 miles of Kelsey Creek from east section line
3	of T32S, R9W, sec. 34, W.M. to the confluence
4	with the Rogue River as a wild river.
5	"(B) East fork kelsey creek.—The
6	approximately 4.6 miles of East Fork Kelsey
7	Creek from the Wild Rogue Wilderness bound-
8	ary in T33S, R8W, sec. 5, W.M. to the con-
9	fluence with Kelsey Creek as a wild river.
10	"(C) Whisky creek.—
11	"(i) The approximately 0.6 miles of
12	Whisky Creek from the confluence of the
13	East Fork and West Fork to 0.1 miles
14	downstream from road 33-8-23 as a rec-
15	reational river.
16	"(ii) The approximately 1.9 miles of
17	Whisky Creek from 0.1 miles downstream
18	from road 33-8-23 to the confluence with
19	the Rogue River as a wild river.
20	"(D) East fork whisky creek.—
21	"(i) The approximately 2.8 miles of
22	East Fork Whisky Creek from the Wild
23	Rogue Wilderness boundary in T33S,
24	R8W, sec. 11, W.M. to 0.1 miles down-

1	stream of road 33-8-26 crossing as a wild
2	river.
3	"(ii) The approximately .3 miles of
4	East Fork Whisky Creek from 0.1 miles
5	downstream of road 33-8-26 to the con-
6	fluence with Whisky Creek as a rec-
7	reational river.
8	"(E) West fork whisky creek.—The
9	approximately 4.8 miles of West Fork Whisky
10	Creek from its headwaters to the confluence
11	with Whisky Creek as a wild river.
12	"(F) Big windy creek.—
13	"(i) The approximately 1.5 miles of
14	Big Windy Creek from its headwaters to
15	0.1 miles downstream from road 34-9-17.1
16	as a scenic river.
17	"(ii) The approximately 5.8 miles of
18	Big Windy Creek from 0.1 miles down-
19	stream from road 34-9-17.1 to the con-
20	fluence with the Rogue River as a wild
21	river.
22	"(G) East fork big windy creek.—
23	"(i) The approximately 0.2 miles of
24	East Fork Big Windy Creek from its head-

1	waters to 0.1 miles downstream from road
2	34-8-36 as a scenic river.
3	"(ii) The approximately 3.7 miles of
4	East Fork Big Windy Creek from 0.1
5	miles downstream from road 34-8-36 to
6	the confluence with Big Windy Creek as a
7	wild river.
8	"(H) LITTLE WINDY CREEK.—The ap-
9	proximately 1.9 miles of Little Windy Creek
10	from 0.1 miles downstream of road 34-8-36 to
11	the confluence with the Rogue River as a wild
12	river.
13	"(I) Howard Creek.—
14	"(i) The approximately 0.3 miles of
15	Howard Creek from its headwaters to 0.1
16	miles downstream of road 34-9-34 as a
17	scenic river.
18	"(ii) The approximately 6.9 miles of
19	Howard Creek from 0.1 miles downstream
20	of road 34-9-34 to the confluence with the
21	Rogue River as a wild river.
22	"(J) Mule creek.—The approximately
23	6.3 miles of Mule Creek from east section line
24	of T32S, R10W, sec. 25, W.M to the confluence
25	with the Rogue River as a wild river.

1	"(K) Anna creek.—The approximately
2	3.5-mile section of Anna Creek from its head-
3	waters to the confluence with Howard Creek as
4	a wild river.
5	"(L) Missouri creek.—The approxi-
6	mately 1.6 miles of Missouri Creek from the
7	Wild Rogue Wilderness boundary in T33S,
8	R10W, sec. 24, W.M. to the confluence with the
9	Rogue River as a wild river.
10	"(M) Jenny Creek.—The approximately
11	1.8 miles of Jenny Creek from the Wild Rogue
12	Wilderness boundary in T33S, R9W, sec.28,
13	W.M. to the confluence with the Rogue River as
14	a wild river.
15	"(N) Rum creek.—The approximately 2.2
16	miles of Rum Creek from the Wild Rogue Wil-
17	derness boundary in T34S, R8W, sec. 9, W.M.
18	to the confluence with the Rogue River as a
19	wild river.
20	"(O) East fork rum creek.—The ap-
21	proximately 1.5 miles of East Rum Creek from
22	the Wild Rogue Wilderness boundary in T34S,
23	R8W, sec. 10, W.M. to the confluence with
	, , , , , , , , , , , , , , , , , , , ,

Rum Creek as a wild river.

1	"(P) WILDCAT CREEK.—The approxi-
2	mately 1.7-mile section of Wildcat Creek from
3	its headwaters downstream to the confluence
4	with the Rogue River as a wild river.
5	"(Q) Montgomery creek.—The approxi-
6	mately 1.8-mile section of Montgomery Creek
7	from its headwaters downstream to the con-
8	fluence with the Rogue River as a wild river.
9	"(R) Hewitt Creek.—The approximately
10	1.2 miles of Hewitt Creek from the Wild Rogue
11	Wilderness boundary in T33S, R9W, sec. 19,
12	W.M. to the confluence with the Rogue River as
13	a wild river.
14	"(S) Bunker creek.—The approximately
15	6.6 miles of Bunker Creek from its headwaters
16	to the confluence with the Rogue River as a
17	wild river.
18	"(T) Dulog creek.—
19	"(i) The approximately 0.8 miles of
20	Dulog Creek from its headwaters to 0.1
21	miles downstream of road 34-8-36 as a
22	scenic river.
23	"(ii) The approximately 1.0 miles of
24	Dulog Creek from 0.1 miles downstream of

1	road 34-8-36 to the confluence with the
2	Rogue River as a wild river.
3	"(U) QUAIL CREEK.—The approximately
4	1.7 miles of Quail Creek from the Wild Rogue
5	Wilderness boundary in T33S, R10W, sec. 1,
6	W.M. to the confluence with the Rogue River as
7	a wild river.
8	"(V) Meadow creek.—The approxi-
9	mately 4.1 miles of Meadow Creek from its
10	headwaters to the confluence with the Rogue
11	River as a wild river.
12	"(W) Russian creek.—The approxi-
13	mately 2.5 miles of Russian Creek from the
14	Wild Rogue Wilderness boundary in T33S,
15	R8W, sec. 20, W.M. to the confluence with the
16	Rogue River as a wild river.
17	"(X) ALDER CREEK.—The approximately
18	1.2 miles of Alder Creek from its headwaters to
19	the confluence with the Rogue River as a wild
20	river.
21	"(Y) BOOZE CREEK.—The approximately
22	1.5 miles of Booze Creek from its headwaters
23	to the confluence with the Rogue River as a
24	wild river.

1	"(Z) Bronco creek.—The approximately
2	1.8 miles of Bronco Creek from its headwaters
3	to the confluence with the Rogue River as a
4	wild river.
5	"(AA) Copsey creek.—The approxi-
6	mately 1.5 miles of Copsey Creek from its head-
7	waters to the confluence with the Rogue River
8	as a wild river.
9	"(BB) Corral Creek.—The approxi-
10	mately 0.5 miles of Corral Creek from its head-
11	waters to the confluence with the Rogue River
12	as a wild river.
13	"(CC) Cowley Creek.—The approxi-
14	mately 0.9 miles of Cowley Creek from its head-
15	waters to the confluence with the Rogue River
16	as a wild river.
17	"(DD) DITCH CREEK.—The approximately
18	1.8 miles of Ditch Creek from the Wild Rogue
19	Wilderness boundary in T33S, R9W, sec. 5,
20	W.M. to its confluence with the Rogue River as
21	a wild river.
22	"(EE) Francis creek.—The approxi-
23	mately 0.9 miles of Francis Creek from its
24	headwaters to the confluence with the Rogue
25	River as a wild river.

1	"(FF) Long gulch.—The approximately
2	1.1 miles of Long Gulch from the Wild Rogue
3	Wilderness boundary in T33S, R10W, sec. 23,
4	W.M. to the confluence with the Rogue River as
5	a wild river.
6	"(GG) Bailey creek.—The approxi-
7	mately 1.7 miles of Bailey Creek from the west
8	section line of T34S, R8W, sec.14, W.M. to the
9	confluence of the Rogue River as a wild river.
10	"(HH) Shady creek.—The approxi-
11	mately 0.7 miles of Shady Creek from its head-
12	waters to the confluence with the Rogue River
13	as a wild river.
14	"(II) SLIDE CREEK.—
15	"(i) The approximately 0.5-mile sec-
16	tion of Slide Creek from its headwaters to
17	0.1 miles downstream from road 33-9-6 as
18	a scenic river.
19	"(ii) The approximately 0.7-mile sec-
20	tion of Slide Creek from 0.1 miles down-
21	stream of road 33-9-6 to the confluence
22	with the Rogue River as a wild river.".
23	(b) Management.—All wild, scenic, and recreation
24	classified segments designated by the amendment made by

- 1 subsection (a) shall be managed as part of the Rogue Wild
- 2 and Scenic River.
- 3 (c) WITHDRAWAL.—Subject to valid rights, the Fed-
- 4 eral land within the boundaries of the river segments des-
- 5 ignated by the amendment made by subsection (a) is with-
- 6 drawn from all forms of—
- 7 (1) entry, appropriation, or disposal under the
- 8 public land laws;
- 9 (2) location, entry, and patent under the mining
- laws; and
- 11 (3) disposition under all laws pertaining to min-
- eral and geothermal leasing or mineral materials.
- 13 SEC. 3. ADDITIONAL PROTECTIONS FOR ROGUE RIVER
- 14 TRIBUTARIES.
- 15 (a) Protections.—The Federal Energy Regulatory
- 16 Commission shall not license the construction of any dam,
- 17 water conduit, reservoir, powerhouse, transmission line, or
- 18 other project works on or directly affecting any stream
- 19 which is listed in this section, and no department or agen-
- 20 cy of the United States shall assist by loan, grant, license,
- 21 or otherwise in the construction of any water resources
- 22 project on or directly affecting any stream which is listed
- 23 in this section of this Act, except to maintain or repair
- 24 water resources projects that exist on the date of enact-
- 25 ment of this Act. Nothing in this section shall prohibit

- any department or agency of the United States in assisting by loan, grant, license, or otherwise, water resources projects whose primary purpose is ecological or aquatic restoration and which provide a net benefit to water qual-4 5 ity and aquatic resources. 6 (b) WITHDRAWAL.—Subject to valid rights, the Fed-7 eral land within a quarter-mile on each side of the streams 8 listed in this section, is withdrawn from all forms of— 9 (1) entry, appropriation, or disposal under the 10 public land laws; 11 (2) location, entry, and patent under the mining 12 laws; and 13 (3) disposition under all laws pertaining to min-14 eral and geothermal leasing or mineral materials. 15 (c) Stream Segments.— (1) Kelsey Creek.—The approximately 4.5 16 17 miles of Kelsey Creek from its headwaters to the 18 east section line of 32S 9W sec. 34. 19 (2) East fork kelsey creek.—The approxi-20 mately .2 miles of East Fork Kelsey Creek from its 21 headwaters to the Wild Rogue Wilderness boundary
