## A BILL

To amend the Congressional Budget Act of 1974 to establish joint resolutions on the budget, and for other purposes.

Be it enacted by the Senate and House of Representa-1 2 tives of the United States of America in Congress assembled, 3 **SECTION 1. SHORT TITLE.** 4 This Act may be cited as the "Legally Binding Budget Act of 2011". SEC. 2. DEFINITIONS. 7 Section 3 of the Congressional Budget Act of 1974 8 is amended by striking paragraph (4) and inserting the following new paragraph: 10 "(4) The term 'joint resolution on the budget' 11 means— "(A) a joint resolution setting forth the 12 13 budget for the United States Government for a 14 fiscal year as provided in section 301; and 15 "(B) any other joint resolution revising the 16 budget for the United States Government for a 17 fiscal year as described in section 304.". 18 SEC. 3. REVISION OF TIMETABLE. Section 300 of the Congressional Budget Act of 1974 19 (2 U.S.C. 631) is amended to read as follows: 21 "TIMETABLE 22 "Sec. 300.
