A BILL

- To amend title 38, United States Code, to prohibit demonstrations at places of mourning during a funeral, memorial service, or other bereavement ceremony honoring a deceased veteran.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Freedom to Mourn

5 in Peace Act of 2011".

6 SEC. 2. FINDINGS.

7 Congress makes the following findings:

1 (1) The greatness of America is measured in 2 many ways but nowhere is it better reflected than in 3 the costs paid by the men and women who volun-4 tarily assumed the risk of defending the freedoms 5 guaranteed by the Constitution and who, without re-6 luctance or mental reservation, made the supreme 7 sacrifice for their country.

8 (2) It is altogether fitting and proper for the 9 friends and families of those fallen in battle to be 10 able to mourn their loss in peace and take comfort 11 and pride in the consolation that comes from the 12 certain knowledge that they laid so costly a sacrifice 13 on the altar of freedom.

14 (3) That to secure this temporary but hallowed 15 moment of peace, reflection, and healing, it is appro-16 priate to place reasonable restrictions on those indi-17 viduals and groups who seek to use the occasion of 18 a funeral, burial, or memorial service of a veteran to 19 stage a public demonstration intended to turn a pri-20 vate gathering of private persons into a public spec-21 tacle for the unconscionable purpose of attracting 22 public attention and gratuitously inflicting unneces-23 sary emotional pain on the deceased veteran's families and friends. 24

1 (4) Funerals, memorial services, and bereave-2 ment ceremonies are special events warranting spe-3 cial respect for the deceased and due regard for the 4 emotional well-being of the bereaved whose memories of the final moments before their loved one is laid 5 6 to rest may be permanently stained were the occa-7 sion allowed to be exploited by others for the pur-8 pose of attracting public attention by the intentional 9 infliction of emotional distress on the loved ones of 10 the deceased.

11 (5) The First Amendment that veterans risked 12 their lives to defend and preserve is broad and 13 strong enough to protect vigorous and robust public 14 debate on public issues and generous enough to ac-15 commodate the natural desire and need of relatives 16 and loved ones to be free to mourn their loss in 17 peace.

18 SEC. 3. PROHIBITION ON DEMONSTRATIONS WHERE FU-

(a) IN GENERAL.—Section 2413 of title 38, United
States Code, is amended to read as follows:

1	"§2413. Prohibition on demonstrations where a fu-
2	neral, memorial service, or other bereave-
3	ment ceremony for a veteran is held
4	"(a) PROHIBITION.—No person may carry out—
5	"(1) a demonstration on the property where a
6	funeral for a veteran is held unless the demonstra-
7	tion has been approved by the cemetery super-
8	intendent or the owner of the property on which the
9	funeral is held; or
10	((2) with respect to such a cemetery or other
11	property on which a funeral is held, a demonstration
12	during the period beginning 60 minutes before and
13	ending 60 minutes after such funeral, any part of
14	which demonstration—
15	"(A)(i) takes place within 150 feet of a
16	road, pathway, or other route of ingress to or
17	egress from such cemetery or other property;
18	and
19	"(ii) includes, as part of such demonstra-
20	tion, any individual willfully making or assisting
21	in the making of any noise or diversion that
22	disturbs or tends to disturb the peace or good
23	order of the funeral; or
24	"(B) is within 1,000 feet of such cemetery
25	or other property and impedes the access to or
26	egress from such cemetery or other property,

2 distance specified in this sentence from such cemetery or
3 other property, a sign which clearly and conspicuously
4 states that a funeral will be held on such cemetery or other
5 property and so states the time interval during which the
6 funeral will be held.

7	"(b) DEFINITIONS.—For purposes of this section:
8	((1) The term 'demonstration' includes the fol-
9	lowing:

10 "(A) Any picketing or similar conduct.
11 "(B) Any oration, speech, use of sound

"(B) Any oration, speech, use of sound
amplification equipment or device, or similar
conduct that is not part of a funeral.

14 "(C) The display of any placard, banner,
15 flag, or similar device, unless such a display is
16 part of a funeral.

17 "(D) The distribution of any handbill,
18 pamphlet, leaflet, or other written or printed
19 matter other than a program distributed as
20 part of a funeral.

21 "(2) The term 'funeral' includes a memorial
22 service or any other bereavement ceremony honoring
23 a veteran.".

24 (b) CLERICAL AMENDMENT.—The table of sections25 at the beginning of such chapter is amended by striking

1 the item relating to section 2413 and inserting the fol-

2 lowing new item:

"2413. Prohibition on demonstrations where a funeral, memorial service, or other bereavement ceremony for a veteran is held.".
