- 3 SECTION 1. REPEALING PATIENT-CENTERED OUTCOMES
- 4 RESEARCH.
- 5 (a) Social Security Act.—Part D of title XI of
- 6 the Social Security Act (42 U.S.C. 1320e et seq.), as
- 7 added by section 6301 of the Patient Protection and Af-
- 8 fordable Care Act, is repealed.

- 1 (b) Public Health Service Act.—Section 937 of
- 2 the Public Health Service Act (42 U.S.C. 299b–37), as
- 3 added by section 6301(b) of the Patient Protection and
- 4 Affordable Care Act, is repealed.
- 5 (c) Internal Revenue Code of 1986.—
- 6 (1) Section 9511 of the Internal Revenue Code
- of 1986, as added by section 6301(e)(1) of the Pa-
- 8 tient Protection and Affordable Care Act, is re-
- 9 pealed, and the table of sections for subchapter A of

- 18 (d) Rescission of Unobligated Funds.—Of the

- 21 Security Act (42 U.S.C. 1320e(b)(3)), the unobligated bal-

- 20 titled "Budgetary Effects of PAYGO Legislation" for this
- 21 Act, submitted for printing in the Congressional Record
- 22 by the Chairman of the House Budget Committee, pro-

- 24 vote on passage.
