A BILL

To amend the Small Business Act with respect to goals for procurement contracts awarded to small business concerns, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Government Efficiency*
 5 *through Small Business Contracting Act of 2012”.*

6 **SEC. 2. GOALS FOR PROCUREMENT CONTRACTS AWARDED**
 7 **TO SMALL BUSINESS CONCERNS.**

8 (a) *IN GENERAL.*—Section 15(g) of the *Small Business*
 9 *Act (15 U.S.C. 644(g)) is amended by striking the sub-*
 10 *section enumerator and inserting the following:*

11 “(g) *GOALS FOR PROCUREMENT CONTRACTS AWARD-*
 12 *ED TO SMALL BUSINESS CONCERNS.—”.*

13 (b) *GOVERNMENTWIDE GOALS.*—Paragraph (1) of sec-
 14 *tion 15(g) of such Act (15 U.S.C. 644(g)) is amended to*
 15 *read as follows:*

16 “(1) *GOVERNMENTWIDE GOALS.*—*The President*
 17 *shall annually establish Governmentwide goals for*
 18 *procurement contracts awarded to small business con-*
 19 *cerns, small business concerns owned and controlled*
 20 *by service-disabled veterans, qualified HUBZone*
 21 *small business concerns, small business concerns*
 22 *owned and controlled by socially and economically*
 23 *disadvantaged individuals, and small business con-*
 24 *cerns owned and controlled by women in accordance*
 25 *with the following:*

1 “(A) The Governmentwide goal for partici-
2 pation by small business concerns shall be estab-
3 lished at not less than 25 percent of the total
4 value of all prime contract awards for each fiscal
5 year and 40 percent of the total value of all sub-
6 contract awards for each fiscal year.

7 “(B) The Governmentwide goal for partici-
8 pation by small business concerns owned and
9 controlled by service-disabled veterans shall be es-
10 tablished at not less than 3 percent of the total
11 value of all prime contract and at not less than
12 3 percent of the total value of all subcontract
13 awards for each fiscal year.

14 “(C) The Governmentwide goal for partici-
15 pation by qualified HUBZone small business
16 concerns shall be established at not less than 3
17 percent of the total value of all prime contract
18 and at not less than 3 percent of the total value
19 of all subcontract awards for each fiscal year.

20 “(D) The Governmentwide goal for partici-
21 pation by small business concerns owned and
22 controlled by socially and economically dis-
23 advantaged individuals shall be established at
24 not less than 5 percent of the total value of all
25 prime contract and at not less than 5 percent of

1 *the total value of all subcontract awards for each*
2 *fiscal year.*

3 “(E) *The Governmentwide goal for partici-*
4 *pation by small business concerns owned and*
5 *controlled by women shall be established at not*
6 *less than 5 percent of the total value of all prime*
7 *contract and at not less than 5 percent of the*
8 *total value of all subcontract awards for each fis-*
9 *cal year.”.*

10 (c) *AGENCY GOALS.—Paragraph (2) of section 15(g)*
11 *of such Act (15 U.S.C. 644(g)) is amended to read as fol-*
12 *lows:*

13 “(2) *AGENCY GOALS.—*

14 “(A) *ESTABLISHMENT.—The head of each*
15 *Federal agency shall annually establish, for the*
16 *agency that individual heads, goals for procure-*
17 *ment contracts awarded to small business con-*
18 *cerns, small business concerns owned and con-*
19 *trolled by service-disabled veterans, qualified*
20 *HUBZone small business concerns, small busi-*
21 *ness concerns owned and controlled by socially*
22 *and economically disadvantaged individuals,*
23 *and small business concerns owned and con-*
24 *trolled by women.*

1 “(B) *RELATIONSHIP TO GOVERNMENTWIDE*
2 *GOALS.*—

3 “(i) *SCOPE.*—*The goals established by*
4 *the head of a Federal agency under sub-*
5 *paragraph (A) shall be in the same format*
6 *as the goals established by the President*
7 *under paragraph (1) and shall address both*
8 *prime contract and subcontract awards.*

9 “(ii) *REQUIREMENT TO MEET OR EX-*
10 *CEED GOVERNMENTWIDE GOALS.*—*With re-*
11 *spect to each goal for a fiscal year estab-*
12 *lished under subparagraph (A) for a cat-*
13 *egory of small business concern, the partici-*
14 *pation percentage applicable to such goal*
15 *may not be less than the participation per-*
16 *centage applicable to the Governmentwide*
17 *goal for such fiscal year established under*
18 *paragraph (1) for such category.*

19 “(C) *CONSULTATION REQUIRED.*—

20 “(i) *IN GENERAL.*—*In establishing*
21 *goals under subparagraph (A), the head of*
22 *each Federal agency shall consult with the*
23 *Administrator.*

24 “(ii) *DISAGREEMENTS.*—*If the Admin-*
25 *istrator and the head of a Federal agency*

1 *fail to agree on a goal established under*
2 *subparagraph (A), the disagreement shall be*
3 *submitted to the Administrator for Federal*
4 *Procurement Policy for final determination.*

5 “(D) *PLAN FOR ACHIEVING GOALS.*—After
6 *establishing goals under subparagraph (A) for a*
7 *fiscal year, the head of each Federal agency shall*
8 *develop a plan for achieving such goals, which*
9 *shall apportion responsibilities among the em-*
10 *ployees of such agency having procurement pow-*
11 *ers.*

12 “(E) *EXPANDED PARTICIPATION.*—In estab-
13 *lishing goals under subparagraph (A), the head*
14 *of each Federal agency shall make a consistent*
15 *effort to annually expand participation by small*
16 *business concerns from each industry category in*
17 *procurement contracts of such agency, including*
18 *participation by small business concerns owned*
19 *and controlled by service-disabled veterans,*
20 *qualified HUBZone small business concerns,*
21 *small business concerns owned and controlled by*
22 *socially and economically disadvantaged indi-*
23 *viduals, and small business concerns owned and*
24 *controlled by women.*

1 “(F) *CONSIDERATION.*—*The head of each*
 2 *Federal agency, in attempting to attain ex-*
 3 *panded participation under subparagraph (E),*
 4 *shall consider—*

5 “(i) *contracts awarded as the result of*
 6 *unrestricted competition; and*

7 “(ii) *contracts awarded after competi-*
 8 *tion restricted to eligible small business con-*
 9 *cerns under this section and under the pro-*
 10 *gram established under section 8(a).*

11 “(G) *COMMUNICATION REGARDING GOALS.*—

12 “(i) *IMPORTANCE OF ACHIEVING*
 13 *GOALS.*—*Each procurement employee or*
 14 *program manager described in clause (ii)*
 15 *shall communicate to the subordinates of the*
 16 *procurement employee or program manager*
 17 *the importance of achieving goals estab-*
 18 *lished under subparagraph (A).*

19 “(ii) *PROCUREMENT EMPLOYEES OR*
 20 *PROGRAM MANAGERS DESCRIBED.*—*A pro-*
 21 *curement employee or program manager de-*
 22 *scribed in this clause is a senior procure-*
 23 *ment executive, senior program manager, or*
 24 *Director of Small and Disadvantaged Busi-*

1 *ness Utilization of a Federal agency having*
 2 *contracting authority.”.*

3 *(d) ENFORCEMENT; DETERMINATIONS OF THE TOTAL*
 4 *VALUE OF CONTRACT AWARDS.—Section 15(g) of the Small*
 5 *Business Act (15 U.S.C. 644(g)), as amended by this Act,*
 6 *is further amended by adding at the end the following:*

7 *“(3) ENFORCEMENT.—If the Administrator does*
 8 *not issue the report required in subsection (h)(2) on*
 9 *or before the date that is 120 days after the end of*
 10 *the prior fiscal year, the Administrator may not*
 11 *carry out or establish any pilot program until the*
 12 *date on which the Administrator issues the report.*

13 *“(4) DETERMINATIONS OF THE TOTAL VALUE OF*
 14 *CONTRACT AWARDS.—For purposes of the goals estab-*
 15 *lished under paragraphs (1) and (2), the total value*
 16 *of contract awards for a fiscal year may not be deter-*
 17 *mined in a manner that excludes the value of a con-*
 18 *tract based on—*

19 *“(A) where the contract is awarded;*

20 *“(B) where the contract is performed;*

21 *“(C) whether the contract is mandated by*
 22 *Federal law to be performed by an entity other*
 23 *than a small business concern;*

24 *“(D) whether funding for the contract is*
 25 *made available in an appropriations Act, if the*

1 *contract is subject to the Competition in Con-*
 2 *tracting Act of 1984; or*

3 *“(E) whether the contract is subject to the*
 4 *Federal Acquisition Regulation.”.*

5 **SEC. 3. REPORTING ON GOALS FOR PROCUREMENT CON-**
 6 **TRACTS AWARDED TO SMALL BUSINESS CON-**
 7 **CERNS.**

8 *Subsection (h) of section 15 of the Small Business Act*
 9 *(15 U.S.C. 644) is amended to read as follows:*

10 *“(h) REPORTING ON GOALS FOR PROCUREMENT CON-*
 11 *TRACTS AWARDED TO SMALL BUSINESS CONCERNS.—*

12 *“(1) AGENCY REPORTS.—At the conclusion of*
 13 *each fiscal year, the head of each Federal agency shall*
 14 *submit to the Administrator a report describing—*

15 *“(A) the extent of the participation by small*
 16 *business concerns, small business concerns owned*
 17 *and controlled by veterans (including service-dis-*
 18 *abled veterans), qualified HUBZone small busi-*
 19 *ness concerns, small business concerns owned and*
 20 *controlled by socially and economically dis-*
 21 *advantaged individuals, and small business con-*
 22 *cerns owned and controlled by women in the pro-*
 23 *curement contracts of such agency during such*
 24 *fiscal year;*

1 “(B) whether the agency achieved the goals
2 established for the agency under subsection
3 (g)(2)(A) with respect to such fiscal year; and

4 “(C) any justifications for a failure to
5 achieve such goals.

6 “(2) *REPORTS BY ADMINISTRATOR.*—Not later
7 than 60 days after receiving a report from each Fed-
8 eral agency under paragraph (1) with respect to a fis-
9 cal year, the Administrator shall submit to the Presi-
10 dent and Congress, and to make available on a public
11 website, a report that includes—

12 “(A) a copy of each report submitted to the
13 Administrator under paragraph (1);

14 “(B) a determination of whether each goal
15 established by the President under subsection
16 (g)(1) for such fiscal year was achieved;

17 “(C) a determination of whether each goal
18 established by the head of a Federal agency
19 under subsection (g)(2)(A) for such fiscal year
20 was achieved;

21 “(D) the reasons for any failure to achieve
22 a goal established under paragraph (1) or (2)(A)
23 of subsection (g) for such fiscal year and a de-
24 scription of actions planned by the applicable
25 agency to address such failure, except that the

1 *Administrator must concur with each remedi-*
2 *ation plan;*

3 *“(E) for the Federal Government and each*
4 *Federal agency, an analysis of the number and*
5 *dollar amount of prime contracts awarded dur-*
6 *ing such fiscal year to—*

7 *“(i) small business concerns—*

8 *“(I) in the aggregate;*

9 *“(II) through sole source con-*
10 *tracts;*

11 *“(III) through competitions re-*
12 *stricted to small business concerns; and*

13 *“(IV) through unrestricted com-*
14 *petition;*

15 *“(ii) small business concerns owned*
16 *and controlled by service-disabled vet-*
17 *erans—*

18 *“(I) in the aggregate;*

19 *“(II) through sole source con-*
20 *tracts;*

21 *“(III) through competitions re-*
22 *stricted to small business concerns;*

23 *“(IV) through competitions re-*
24 *stricted to small business concerns*

1 *owned and controlled by service-dis-*
2 *abled veterans; and*

3 “(V) *through unrestricted com-*
4 *petition;*

5 “(iii) *qualified HUBZone small busi-*
6 *ness concerns—*

7 “(I) *in the aggregate;*

8 “(II) *through sole source con-*
9 *tracts;*

10 “(III) *through competitions re-*
11 *stricted to small business concerns;*

12 “(IV) *through competitions re-*
13 *stricted to qualified HUBZone small*
14 *business concerns;*

15 “(V) *through unrestricted com-*
16 *petition where a price evaluation pref-*
17 *erence was used; and*

18 “(VI) *through unrestricted com-*
19 *petition where a price evaluation pref-*
20 *erence was not used;*

21 “(iv) *small business concerns owned*
22 *and controlled by socially and economically*
23 *disadvantaged individuals—*

24 “(I) *in the aggregate;*

1 “(II) through sole source con-
2 tracts;

3 “(III) through competitions re-
4 stricted to small business concerns;

5 “(IV) through competitions re-
6 stricted to small business concerns
7 owned and controlled by socially and
8 economically disadvantaged individ-
9 uals;

10 “(V) through unrestricted com-
11 petition; and

12 “(VI) by reason of that concern’s
13 certification as a small business owned
14 and controlled by socially and eco-
15 nomically disadvantaged individuals;

16 “(v) small business concerns owned by
17 an Alaska Native Corporation—

18 “(I) in the aggregate;

19 “(II) through sole source con-
20 tracts;

21 “(III) through competitions re-
22 stricted to small business concerns;

23 “(IV) through competitions re-
24 stricted to small business concerns
25 owned and controlled by socially and

1 *economically disadvantaged individ-*
2 *uals; and*

3 *“(V) through unrestricted com-*
4 *petition; and*

5 *“(vi) small business concerns owned*
6 *and controlled by women—*

7 *“(I) in the aggregate;*

8 *“(II) through competitions re-*
9 *stricted to small business concerns;*

10 *“(III) through competitions re-*
11 *stricted using the authority under sec-*
12 *tion 8(m)(2);*

13 *“(IV) through competitions re-*
14 *stricted using the authority under sec-*
15 *tion 8(m)(2) and in which the waiver*
16 *authority under section 8(m)(3) was*
17 *used; and*

18 *“(V) through unrestricted com-*
19 *petition; and*

20 *“(F) for the Federal Government and each*
21 *Federal agency, the number, dollar amount, and*
22 *distribution with respect to the North American*
23 *Industry Classification System of subcontracts*
24 *awarded during such fiscal year to small busi-*
25 *ness concerns, small business concerns owned and*

1 *controlled by service-disabled veterans, qualified*
 2 *HUBZone small business concerns, small busi-*
 3 *ness concerns owned and controlled by socially*
 4 *and economically disadvantaged individuals,*
 5 *and small business concerns owned and con-*
 6 *trolled by women.”.*

7 **SEC. 4. SENIOR EXECUTIVES.**

8 (a) *TRAINING.*—*Programs established for the develop-*
 9 *ment of senior executives under section 3396(a) of title 5,*
 10 *United States Code, shall include training with respect to*
 11 *Federal procurement requirements, including contracting*
 12 *requirements under the Small Business Act (15 U.S.C. 631*
 13 *et seq.).*

14 (b) *SABBATICALS.*—*If a Federal agency does not*
 15 *achieve, with respect to a fiscal year, a goal established by*
 16 *the head of such agency under section 15(g)(2)(A) of the*
 17 *Small Business Act (15 U.S.C. 644(g)(2)(A)), a senior exec-*
 18 *utive within that agency may not be granted, during the*
 19 *succeeding fiscal year, a sabbatical under section 3396(c)*
 20 *of title 5, United States Code.*

21 (c) *INCENTIVE AWARDS.*—*If a Federal agency does not*
 22 *achieve, with respect to a fiscal year, a goal established by*
 23 *the head of such agency under section 15(g)(2)(A) of the*
 24 *Small Business Act (15 U.S.C. 644(g)(2)(A)), a senior exec-*
 25 *utive within that agency may not receive, during the suc-*

1 ceeding fiscal year, any incentive award under subchapter
2 I of chapter 45 of title 5, United States Code.

3 (d) *SENIOR EXECUTIVE DEFINED.*—In this section, the
4 term “senior executive” has the meaning given that term
5 in section 3132(a) of title 5, United States Code.

6 **SEC. 5. SENSE OF CONGRESS.**

7 *It is the sense of Congress that the contracting provi-*
8 *sions of the Small Business Act shall apply to the leasing*
9 *of buildings and office space by the United States, and shall*
10 *not apply to any leasing transaction between private par-*
11 *ties.*
