22	2012 APPROPRIATED AMOUNTS BASED ON
23	FUELS TAX RECEIPTS.—Amounts transferred
24	on or before the date of the enactment of this
25	paragraph to the Mass Transit Account in the

Highway Trust Fund for fiscal year 2012 are hereby transferred to the Highway Account of the Highway Trust Fund (as defined in paragraph (5)(B)).".

- (2) Conforming amendment.—The heading for subsection (e) of section 9503 of such Code is amended by striking "Mass Transit Account" and inserting "Alternative Transportation Account".
