A BILL

To amend the Small Business Act with respect to small business concern size standards, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Business Protec-

5 tion Act of 2012”.

6 **SEC. 2. SMALL BUSINESS CONCERN SIZE STANDARDS.**

7 Section 3 of the Small Business Act (15 U.S.C. 632)

8 is amended—

9 ~~(1) by inserting after the section enumerator~~
10 the following: “**DEFINITIONS.**”; and

11 (1) by striking “SEC. 3.” and inserting the fol-

12 lowing:

13 “**SEC. 3. DEFINITIONS.**”; and

14 (2) in subsection (a)—

15 (A) by striking the subsection enumerator

16 and inserting the following:

17 “(a) SMALL BUSINESS CONCERNS.—”;

18 (B) in paragraph (1) by striking “(1) For

19 the purposes” and inserting the following:

20 “(1) IN GENERAL.—For the purposes”;

21 (C) in paragraph (3) by striking “(3)

22 When establishing” and inserting the following:

23 “(3) VARIATION BY INDUSTRY AND CONSIDER-

24 ATION OF OTHER FACTORS.—When establishing”;

1 (D) by moving paragraph (5), including
2 each subparagraph and clause therein, 2 ems to
3 the right; and

4 (E) by adding at the end the following:

5 “(6) COMMON SIZE STANDARDS.—In carrying
6 out this subsection, the Administrator may establish
7 or approve a single size standard for a grouping of
8 four digit North American Industrial Classification
9 codes only if the Administrator makes publicly avail-
10 able, not later than the date on which such size
11 standard is established or approved, a justification
12 demonstrating that such size standard is appropriate
13 for each individual industry classification included in
14 the grouping.

15 “(7) PROPOSED RULE MAKING.—~~In conducting~~
16 ~~rulemaking to revise, modify or establish size stand-~~
17 ~~ards pursuant to this section, the Administrator~~
18 ~~shall consider and address the following~~ *In con-*
19 *ducting rulemaking to revise, modify or establish size*
20 *standards pursuant to this section, the Administrator*
21 *shall consider, and address, and make publicly avail-*
22 *able as part of the notice of proposed rule making and*
23 *notice of final rule each of the following:*

24 “(A) a detailed description of the industry
25 for which the new size standard is proposed;

1 “(B) an analysis of the competitive envi-
2 ronment for that industry;

3 “(C) the approach the Administrator used
4 to develop the proposed standard including the
5 source of all data used to develop the proposed
6 rulemaking; and

7 “(D) the anticipated effect of the proposed
8 rulemaking on the industry, including the num-
9 ber of concerns not currently considered small
10 that would be considered small under the pro-
11 posed rulemaking and the number of concerns
12 currently considered small that would be
13 deemed other than small under the proposed
14 rulemaking.”.

15 “(8) *NUMBER OF SIZE STANDARDS.*—*The Ad-*
16 *ministrator shall not limit the number of size stand-*
17 *ards it creates pursuant to paragraph (2), and shall*
18 *assign the appropriate size standard to each North*
19 *American Industrial Classification System Code.”.*
