Mr. Pascrell (for himself and Mr. Carnahan) introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To amend title 49, United States Code, to improve transportation for seniors, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Senior Transportation
- 5 and Mobility Improvement Act of 2012".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:
- 8 (1) According to projections from the 2010 de-
- 9 cennial census, the number of individuals in the
- 10 United States who are 65 years of age or older will

- increase from 40,000,000 in 2010 to 72,000,000 in 2030. Yet, a 2004 report by the Surface Transportation Policy Project found that more than 1 in 5 (or 21 percent) of individuals who are 65 years of age or older do not drive.
 - (2) According to a 2011 report by the National Association of Area Agencies on Aging, inadequate transportation options for older adults has emerged as the second greatest challenge identified by communities during the 5-year period ending in 2011.
 - (3) According to a 2004 report by the Surface Transportation Policy Project, more than ½ of seniors who are 65 years of age and older (numbering 3,600,000 individuals) who no longer drive due to a decline in health, stay at home on any given day partially because they lack transportation options. Alternatives to driving are particularly sparse in some regions and in rural and small town communities.
 - (4) According to a 2004 report by the Surface Transportation Policy Project, compared with older drivers, older non-drivers in the United States make 15 percent fewer trips to the doctor, 59 percent fewer shopping trips, and 65 percent fewer trips for social, family, and religious activities.

1	(5) In 2009, the program under section 5310 of
2	title 49, United States Code, provided more than
3	43,000,000 rides to older adults and people with dis-
4	abilities.
5	(6) Access to mobility management services
6	help transit and human services systems meet the
7	needs of older adults and people with disabilities.
8	This person-centered strategy helps individuals and
9	families review available transportation options and
10	support their decisions regarding the transportation
11	options that are best suited to their circumstances,
12	preferences and mobility needs.

1	SEC. 5. TECHNICAL ASSISTANCE AND MOBILITY MANAGE-
2	MENT.
3	(a) Technical Assistance.—
4	(1) Definition.—For purposes of this sub-
5	section—
6	(A) the term "eligible entity" means a
7	nonprofit organization that provides transpor-
8	tation services to older individuals;
9	(B) the term "older individual" has the
10	same meaning as in section 102 of the Older
11	Americans Act of 1965 (42 U.S.C. 3002); and
12	(C) the term "urbanized area" has the
13	same meaning as in section 5302 of title 49,
14	United States Code.
15	(2) In General.—The Administrator of the
16	Federal Transit Administration shall enter into a co-
17	operative agreement with the National Center on
18	Senior Transportation—
19	(A) to provide technical assistance to tran-
20	sit and human services organizations;
21	(B) to disseminate best practices with re-
22	spect to transportation for older individuals to
23	consumers, Federal, State, and local transpor-
24	tation and aging services providers, and re-
25	searchers; and

1	(C) to make grants to eligible entities to
2	test innovative and replicable approaches for
3	addressing the mobility needs of older individ-
4	uals, including individuals in other than urban-
5	ized areas.
6	(3) Authorization of appropriations.—
7	There are authorized to be appropriated to carry out
8	this subsection—
9	(A) $$5,500,000$ for fiscal year 2012; and
10	(B) $$6,000,000$ for fiscal year 2013.
11	(b) Mobility Management Program.—
12	(1) IN GENERAL.—The Federal Transit Admin-
13	istration shall make grants to nonprofit aging serv-
14	ices organizations—
15	(A) to offer mobility management services,
16	including mobility management activities and
17	projects described in section 5302(a)(1)(L) of
18	title 49, United States Code; and
19	(B) to develop and implement enhanced
20	technology to support mobility management
21	services.
22	(2) Authorization of appropriations.—
23	There are authorized to be appropriated to carry out
24	this subsection—
25	(A) $\$3,000,000$ for fiscal year 2012; and

1 (B) \$5,000,000 for fiscal year 2013.
