## AN ACT

To amend the Internal Revenue Code of 1986 to repeal  
the excise tax on medical devices.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4       (a) SHORT TITLE.—This Act may be cited as the  
5       “Health Care Cost Reduction Act of 2012”.

6       (b) TABLE OF CONTENTS.—The table of contents for  
7       this Act is as follows:

Sec. 1. Short title; table of contents.

Sec. 2. Repeal of medical device excise tax.

Sec. 3. Repeal of disqualification of expenses for over-the-counter drugs under  
certain accounts and arrangements.

Sec. 4. Taxable distributions of unused balances under health flexible spending  
arrangements.

See. 5. Recapture of overpayments resulting from certain federally-subsidized health insurance.

**1 SEC. 2. REPEAL OF MEDICAL DEVICE EXCISE TAX.**

2 (a) IN GENERAL.—Chapter 32 of the Internal Revenue Code of 1986 is amended by striking subchapter E.

4 (b) CONFORMING AMENDMENTS.—

5 (1) Subsection (a) of section 4221 of such Code is amended by striking the last sentence.

7 (2) Paragraph (2) of section 6416(b) of such Code is amended by striking the last sentence.

9 (c) CLERICAL AMENDMENT.—The table of subchapters for chapter 32 of such Code is amended by striking the item relating to subchapter E.

**12 SEC. 3. REPEAL OF DISQUALIFICATION OF EXPENSES FOR  
OVER-THE-COUNTER DRUGS UNDER CERTAIN  
ACCOUNTS AND ARRANGEMENTS.**

15 (a) HSAs.—Subparagraph (A) of section 223(d)(2) of the Internal Revenue Code of 1986 is amended by striking the last sentence.

18 (b) ARCHER MSAs.—Subparagraph (A) of section 220(d)(2) of such Code is amended by striking the last sentence.

21 (c) HEALTH FLEXIBLE SPENDING ARRANGEMENTS AND HEALTH REIMBURSEMENT ARRANGEMENTS.—Section 106 of such Code is amended by striking subsection 24 (f).

1       (d) EFFECTIVE DATE.—The amendments made by  
2 this section shall apply to expenses incurred after Decem-  
3 ber 31, 2012.

4 SEC. 4. TAXABLE DISTRIBUTIONS OF UNUSED BALANCES  
5 UNDER HEALTH FLEXIBLE SPENDING AR-  
6 RANGEMENTS.

7       (a) IN GENERAL.—Section 125 of the Internal Rev-  
8 enue Code of 1986 is amended by redesignating sub-  
9 sections (k) and (l) as subsections (l) and (m), respec-  
10 tively, and by inserting after subsection (j) the following  
11 new subsection:

12       “(k) TAXABLE DISTRIBUTIONS OF UNUSED BAL-  
13 ANCES UNDER HEALTH FLEXIBLE SPENDING ARRANGE-  
14 MENTS —

15                 “(1) IN GENERAL.—For purposes of this sec-  
16                 tion and sections 105(b) and 106, a plan or other  
17                 arrangement which (but for any qualified distribu-  
18                 tion) would be a health flexible spending arrange-  
19                 ment shall not fail to be treated as a cafeteria plan  
20                 or health flexible spending arrangement (and shall  
21                 not fail to be treated as an accident or health plan)  
22                 merely because such arrangement provides for quali-  
23                 fied distributions.

24               “(2) QUALIFIED DISTRIBUTIONS.—For pur-  
25               poses of this subsection, the term ‘qualified distribu-

1       tion' means any distribution to an individual under  
2       the arrangement referred to in paragraph (1) with  
3       respect to any plan year if—

4                 “(A) such distribution is made after the  
5                 last date on which requests for reimbursement  
6                 under such arrangement for such plan year may  
7                 be made and not later than the end of the 7th  
8                 month following the close of such plan year,  
9                 and

10                “(B) such distribution does not exceed the  
11                 lesser of—

12                 “(i) \$500, or

13                 “(ii) the excess of—

14                         “(I) the salary reduction con-  
15                 tributions made under such arrange-  
16                 ment for such plan year, over

17                         “(II) the reimbursements for ex-  
18                 penses incurred for medical care made  
19                 under such arrangement for such plan  
20                 year.

21                 “(3) TAX TREATMENT OF QUALIFIED DIS-  
22         TRIBUTIONS.—Qualified distributions shall be in-  
23         cludible in the gross income of the employee in the  
24         taxable year in which distributed and shall be taken  
25         into account as wages or compensation under the

1       applicable provisions of subtitle C when so distrib-  
2       uted.

3           “(4) COORDINATION WITH QUALIFIED RESERV-  
4       IST DISTRIBUTIONS.—A qualified reservist distribu-  
5       tion (as defined in subsection (h)(2)) shall not be  
6       treated as a qualified distribution and shall not be  
7       taken into account in applying the limitation of  
8       paragraph (2)(B)(i).”.

9           (b) CONFORMING AMENDMENT.—Paragraph (1) of  
10      section 409A(d) of such Code is amended by striking  
11      “and” at the end of subparagraph (A), by striking the  
12      period at the end of subparagraph (B) and inserting “,  
13      and”, and by adding at the end the following new subpara-  
14      graph:

15               “(C) a health flexible spending arrange-  
16       ment to which subsection (h) or (k) of section  
17       125 applies.”.

18           (c) EFFECTIVE DATE.—The amendments made by  
19      this section shall apply to plan years beginning after De-  
20      cember 31, 2012.

**1 SEC. 5. RECAPTURE OF OVERPAYMENTS RESULTING FROM**

**2 CERTAIN FEDERALLY-SUBSIDIZED HEALTH**

**3 INSURANCE.**

4       (a) IN GENERAL.—Paragraph (2) of section 36B(f)  
5 of the Internal Revenue Code of 1986 is amended by strik-  
6 ing subparagraph (B).

7       (b) CONFORMING AMENDMENT.—So much of para-  
8 graph (2) of section 36B(f) of such Code, as amended by  
9 subsection (a), as precedes “advance payments” is amend-  
10 ed to read as follows:

11               “(2) EXCESS ADVANCE PAYMENTS.—If the”.

12       (c) EFFECTIVE DATE.—The amendments made by  
13 this section shall apply to taxable years ending after De-  
14 cember 31, 2013.
