 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Domestic Energy Inde-
 - 5 pendence and Maritime Jobs Creation Act".
 - 6 SEC. 2. VESSEL DOCUMENTATION EXEMPTION.
 - 7 (a) In General.—Notwithstanding sections 12112
 - 8 and 12132 and chapter 551 of title 46, United States
 - 9 Code, the Secretary of the department in which the Coast

- 1 Guard is operating may issue a certificate of documenta-
- 2 tion with a coastwise endorsement for each of the following
- 3 vessels:
- 4 (1) LNG GEMINI (United States official num-
- 5 ber 595752).
- 6 (2) LNG LEO (United States official number
- 7 595753).
- 8 (3) LNG VIRGO (United States official num-
- 9 ber 595755).
- 10 (b) LIMITATION ON OPERATION.—Coastwise trade
- 11 authorized under subsection (a) shall be limited to car-
- 12 riage of natural gas, as that term is defined in section
- 13 3(13) of the Deepwater Port Act of 1974 (33 U.S.C.
- 14 1502(13)).
- 15 (c) Termination of Effectiveness of Endorse-
- 16 Ments.—The coastwise endorsement issued under sub-
- 17 section (a) for a vessel shall expire on the date of the sale
- 18 of the vessel by the owner of the vessel on the date of
- 19 enactment of this Act to a person who is not related by
- 20 ownership or control to such owner.
- 21 SEC. 3. OPERATION OF DRY DOCK IN KETCHIKAN, ALASKA.
- A vessel transported in Dry Dock #2 (State of Alas-
- 23 ka registration AIDEA FDD-2) is not merchandise for
- 24 purposes of section 55102 of title 46, United States Code,
- 25 if, during such transportation, Dry Dock #2 remains con-

- 1 nected by a utility or other connecting line to pierside
- 2 moorage located in Ketchikan, Alaska.
