- 3 "(2) TELEMEDICINE SERVICES.—The 'telemedicine services' means a telecommunications 5 link to an end user through the use of equipment 6 that electronically links patients and health profes-7 sionals at separate sites in order to exchange health 8 care information in audio, video, graphic, or other 9 format for the purpose of providing health care serv-10 ices.
- 11 "(3) IN-PERSON.—The term 'in-person' in the 12 same room and in the physical presence of the 13 woman.
