AN ACT

Making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2013, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 Department of Homeland Security for the fiscal year end-
- 6 ing September 30, 2013, and for other purposes, namely:

7	For necessary expenses of the Office of the Secretary
8	of Homeland Security, as authorized by section 102 of the
9	Homeland Security Act of 2002 (6 U.S.C. 112), and exec-
10	utive management of the Department of Homeland Secu-
11	rity, as authorized by law, \$121,850,000 (reduced by
12	\$50,000): Provided, That not to exceed \$45,000 shall be
13	for official reception and representation expenses, of which

- 6 dent's budget proposal for fiscal year 2014 pursuant to
- 7 the requirements of section 1105(a) of title 31, United
- 8 States Code: Provided further, That the Secretary of
- 9 Homeland Security shall submit the consolidation plan, as
- 10 directed under the heading "Consolidation of Weapons of
- 11 Mass Destruction Defense Programs" in the accom-
- 12 panying report, not later than 180 days after the date of
- 13 enactment of this Act.

- For necessary expenses of the Office of the Under

- 21 exceed \$2,500 shall be for official reception and represen-
- 22 tation expenses: *Provided*, That of the total amount made

- 11 year 2014 pursuant to the requirements of section

- 2 For necessary expenses of the Office of the Chief Fi-

- 5 of which \$6,700,000 shall remain available until Sep-
- 6 tember 30, 2014 for financial systems modernization ef-
- 7 forts: Provided, That \$29,017,000 shall not be available
- 8 for obligation until the Secretary of Homeland Security
- 9 submits to the Committees on Appropriations of the Sen-
- 10 ate and the House of Representatives all statutorily re-

22	For necessary expenses for enforcement of laws relat-
23	ing to border security, immigration, customs, agricultural

25	animal imports, and transportation of unaccompanied

- 1 minor aliens; purchase and lease of up to 7,500 (6,500
- 2 for replacement only) police-type vehicles; and contracting
- 3 with individuals for personal services abroad;
- 4 \$8,366,024,000 (increased by \$43,000); of which
- 5 \$3,274,000 shall be derived from the Harbor Maintenance
- 6 Trust Fund for administrative expenses related to the col-
- 7 lection of the Harbor Maintenance Fee pursuant to section

- For expenses for U.S. Customs and Border Protec-
- 24 tion automated systems, \$700,242,000 to remain available
- 25 until September 30, 2015, of which not less than

- 1 \$138,794,000 shall be for the development of the Auto-
- 2 mated Commercial Environment.
- 3 BORDER SECURITY FENCING, INFRASTRUCTURE, AND
- 4 TECHNOLOGY
- 5 For expenses for border security fencing, infrastruc-
- 6 ture, and technology, \$327,099,000 (increased by
- 7 \$10,000,000) (reduced by \$3,000,000), to remain avail-
- 8 able until September 30, 2015.
- 9 AIR AND MARINE INTERDICTION, OPERATIONS,
- 10 MAINTENANCE, AND PROCUREMENT
- 11 For necessary expenses for the operations, mainte-
- 12 nance, and procurement of marine vessels, aircraft, un-
- 13 manned aircraft systems, and other related equipment of
- 14 the air and marine program, including operational train-
- 15 ing and mission-related travel, the operations of which in-
- 16 clude the following: the interdiction of narcotics and other
- 17 goods; the provision of support to Federal, State, and local
- 18 agencies in the enforcement or administration of laws en-
- 19 forced by the Department of Homeland Security; and, at
- 20 the discretion of the Secretary of Homeland Security, the
- 21 provision of assistance to Federal, State, and local agen-

- 16 For necessary expenses to plan, acquire, construct,
- 17 renovate, equip, furnish, operate, manage, and maintain
- 18 buildings, facilities, and related infrastructure necessary
- 19 for the administration and enforcement of the laws relat-
- 20 ing to customs, immigration, and border security,
- 21 \$252,567,000, to remain available until September 30,
- 22 2017: Provided, That the Commissioner of U.S. Customs
- 23 and Border Protection shall submit to the Committees on
- 24 Appropriations of the Senate and the House of Represent-
- 25 atives, at the time that the President's budget proposal

- 1 is submitted pursuant to the requirements of section
- 2 1105(a) of title 31, United States Code, an inventory of
- 3 the real property of U.S. Customs and Border Protection
- 4 and a plan for each activity and project proposed for fund-
- 5 ing under this heading that includes the full cost by fiscal
- 6 year of each activity and project proposed and underway

- 8 Immigration and Customs Enforcement
- 9 SALARIES AND EXPENSES
- For necessary expenses for enforcement of immigra-
- 11 tion and customs laws, detention and removals, and inves-
- 12 tigations, including overseas vetted units operations; and
- 13 purchase and lease of up to 3,790 (2,350 for replacement
- 14 only) police-type vehicles; \$5,236,331,000 (reduced by
- 15 \$20,000,000) (increased by \$20,000,000); of which not to
- 16 exceed \$10,000,000 shall be available until expended for
- 17 conducting special operations under section 3131 of the
- 18 Customs Enforcement Act of 1986 (19 U.S.C. 2081); of
- 19 which not to exceed \$12,750 shall be for official reception
- 20 and representation expenses; of which not to exceed
- 21 \$2,000,000 shall be for awards of compensation to inform-
- 22 ants, to be accounted for solely under the certificate of
- 23 the Secretary of Homeland Security; of which not less
- 24 than \$305,000 shall be for promotion of public awareness
- 25 of the child pornography tipline and activities to counter

- 2 shall be used to facilitate agreements consistent with sec-

- 6 cies for the costs associated with the care, maintenance,
- 7 and repatriation of smuggled aliens unlawfully present in
- 8 the United States: *Provided*, That none of the funds made
- 9 available under this heading shall be available to com-
- 10 pensate any employee for overtime in an annual amount
- 11 in excess of \$35,000, except that the Secretary of Home-
- 12 land Security, or the designee of the Secretary, may waive
- 13 that amount as necessary for national security purposes
- 14 and in cases of immigration emergencies: Provided further,
- 15 That of the total amount provided, \$15,770,000 shall be
- 16 for activities to enforce laws against forced child labor,
- 17 of which not to exceed \$6,000,000 shall remain available
- 18 until expended: Provided further, That not less than
- 19 \$10,000,000 shall be available for investigation of intellec-
- 20 tual property rights violations, including the National In-
- 21 tellectual Property Rights Coordination Center: Provided
- 22 further, That not less than \$134,626,000 shall be for
- 23 worksite enforcement investigations, audits, and activities:
- 24 Provided further, That of the total amount available, not
- 25 less than \$1,600,000,000 shall be available to identify

- 1 aliens convicted of a crime who may be deportable, and
- 2 to remove them from the United States once they are
- 3 judged deportable, of which \$138,249,000 shall be for
- 4 completion of Secure Communities deployment: Provided
- 5 further, That the Assistant Secretary of Homeland Secu-
- 6 rity for U.S. Immigration and Customs Enforcement shall
- 7 report to the Committees on Appropriations of the Senate
- 8 and the House of Representatives, not later than 45 days
- 9 after the end of each quarter of the fiscal year, on progress

- 18 pertaining to aliens convicted of a crime.

- For expenses of immigration and customs enforce-
- 21 ment automated systems, \$232,006,000, to remain avail-
- 22 able until September 30, 2015: Provided, That, subject to
- 23 section 503 of this Act, the Secretary of Homeland Secu-
- 24 rity may transfer up to \$5,000,000 to the Office of Bio-
- 25 metric Identity Management to support the transition of

- 1 the Arrival and Departure System: *Provided further*, That
- 2 amounts transferred pursuant to the preceding provision
- 3 shall remain available until September 30, 2014.

- 5 For necessary expenses to plan, construct, renovate,
- 6 equip, and maintain buildings and facilities necessary for
- 7 the administration and enforcement of the laws relating
- 8 to customs and immigration, \$5,450,000, to remain avail-
- 9 able until September 30, 2016.
- 10 Transportation Security Administration
- 11 AVIATION SECURITY
- For necessary expenses of the Transportation Secu-
- 13 rity Administration related to providing civil aviation secu-
- 14 rity services pursuant to the Aviation and Transportation
- 15 Security Act (Public Law 107–71; 115 Stat. 597; 49
- 16 U.S.C. 40101 note), \$5,041,230,000 (increased by
- 17 \$10,000,000) (reduced by \$10,000,000), to remain avail-
- 18 able until September 30, 2014, of which not to exceed
- 19 \$8,500 shall be for official reception and representation
- 20 expenses: Provided, That of the total amount made avail-
- 21 able under this heading, not to exceed \$3,969,569,000
- 22 shall be for screening operations, of which \$409,000,000
- 23 shall be available for explosives detection systems;
- 24 \$120,239,000 shall be for checkpoint support; and not to
- 25 exceed \$1,071,661,000 shall be for aviation security direc-

tion and enforcement: Provided further, That of the amount made available in the preceding proviso for explo-3 sives detection systems, \$100,000,000 shall be available 4 for the purchase and installation of these systems, of which not less than 9 percent shall be available for the purchase and installation of certified explosives detection systems at medium- and small-sized airports: Provided 8 further, That any award to deploy explosives detection systems shall be based on risk, the airport's current reliance 10 on other screening solutions, lobby congestion resulting in increased security concerns, high injury rates, airport 12 readiness, and increased cost effectiveness: Provided further, That security service fees authorized under section 44940 of title 49, United States Code, shall be credited 14 15 to this appropriation as offsetting collections and shall be available only for aviation security: Provided further, That 16 the sum appropriated under this heading from the general fund shall be reduced on a dollar-for-dollar basis as such 18 19 offsetting collections are received during fiscal year 2013 so as to result in a final fiscal year appropriation from 21 the fund estimated more general at not than \$2,971,230,000: Provided further, That any security service fees collected in excess of the amount made available under this heading shall become available during fiscal year 2014: Provided further, That notwithstanding section

- 5 For necessary expenses for the development and im-
- 6 plementation of screening programs of the Office of
- 7 Transportation Threat Assessment and Credentialing,
- 8 \$192,424,000, to remain available until September 30,
- 9 2014.
- 10 Transportation Security Support
- 11 For necessary expenses of the Transportation Secu-
- 12 rity Administration related to transportation security sup-
- 13 port and intelligence pursuant to the Aviation and Trans-
- 14 portation Security Act (Public Law 107-71; 115 Stat.
- 15 597; 49 U.S.C. 40101 note), \$928,663,000, to remain
- 16 available until September 30, 2014: Provided, That the

10	OPERATING EXPENSES
11	For necessary expenses for the operation and mainte-
