Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2013, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 Legislative Branch for the fiscal year ending September
6 30, 2013, and for other purposes, namely:

1 TITLE I—LEGISLATIVE BRANCH

2 HOUSE OF REPRESENTATIVES

3 SALARIES AND EXPENSES

4 For salaries and expenses of the House of Represent-
5 atives, ~~\$1,225,680,000~~, as follows:

6 HOUSE LEADERSHIP OFFICES

7 For salaries and expenses, as authorized by law,
8 ~~\$23,275,773~~, including: Office of the Speaker,
9 ~~\$6,942,770~~, including ~~\$25,000~~ for official expenses of the
10 Speaker; Office of the Majority Floor Leader, ~~\$2,277,595~~,
11 including ~~\$10,000~~ for official expenses of the Majority
12 Leader; Office of the Minority Floor Leader, ~~\$7,432,812~~,
13 including ~~\$10,000~~ for official expenses of the Minority
14 Leader; Office of the Majority Whip, including the Chief
15 Deputy Majority Whip, ~~\$1,971,050~~, including ~~\$5,000~~ for
16 official expenses of the Majority Whip; Office of the Mi-
17 nority Whip, including the Chief Deputy Minority Whip,
18 ~~\$1,524,951~~, including ~~\$5,000~~ for official expenses of the
19 Minority Whip; Republican Conference, ~~\$1,572,788~~;
20 Democratic Caucus, ~~\$1,553,807~~. *Provided*, That such
21 amount for salaries and expenses shall remain available
22 from January 3, 2013 until January 3, 2014.

1 MEMBERS' REPRESENTATIONAL ALLOWANCES
 2 INCLUDING MEMBERS' CLERK HIRE, OFFICIAL
 3 EXPENSES OF MEMBERS, AND OFFICIAL MAIL

4 For Members' representational allowances, including
 5 Members' clerk hire, official expenses, and official mail,
 6 \$573,939,282.

7 COMMITTEE EMPLOYEES

8 STANDING COMMITTEES, SPECIAL AND SELECT

9 For salaries and expenses of standing committees,
 10 special and select, authorized by House resolutions,
 11 \$125,964,870: *Provided*, That such amount shall remain
 12 available for such salaries and expenses until December
 13 31, 2014.

14 COMMITTEE ON APPROPRIATIONS

15 For salaries and expenses of the Committee on Ap-
 16 propriations, \$26,665,785, including studies and examina-
 17 tions of executive agencies and temporary personal serv-
 18 ices for such committee, to be expended in accordance with
 19 section 202(b) of the Legislative Reorganization Act of
 20 1946 and to be available for reimbursement to agencies
 21 for services performed: *Provided*, That such amount shall
 22 remain available for such salaries and expenses until De-
 23 cember 31, 2014.

1 SALARIES, OFFICERS AND EMPLOYEES

2 For compensation and expenses of officers and em-
3 ployees, as authorized by law, ~~\$173,669,084~~, including:
4 for salaries and expenses of the Office of the Clerk, includ-
5 ing not more than \$23,000, of which not more than
6 \$20,000 is for the Family Room, for official representa-
7 tion and reception expenses, ~~\$22,370,252~~; for salaries and
8 expenses of the Office of the Sergeant at Arms, including
9 the position of Superintendent of Garages and the Office
10 of Emergency Management, and including not more than
11 \$3,000 for official representation and reception expenses,
12 ~~\$12,585,000~~, of which ~~\$5,463,251~~ shall remain available
13 until expended; for salaries and expenses of the Office of
14 the Chief Administrative Officer including not more than
15 \$3,000 for official representation and reception expenses,
16 ~~\$116,782,000~~, of which ~~\$3,937,000~~ shall remain available
17 until expended; for salaries and expenses of the Office of
18 the Inspector General, ~~\$4,692,000~~; for salaries and ex-
19 penses of the Office of General Counsel, ~~\$1,415,000~~; for
20 the Office of the Chaplain, ~~\$179,000~~; for salaries and ex-
21 penses of the Office of the Parliamentarian, including the
22 Parliamentarian, ~~\$2,000~~ for preparing the Digest of
23 Rules, and not more than \$1,000 for official representa-
24 tion and reception expenses, ~~\$2,060,000~~; for salaries and
25 expenses of the Office of the Law Revision Counsel of the

1 House, \$3,258,000; for salaries and expenses of the Office
 2 of the Legislative Counsel of the House, \$8,814,000; for
 3 salaries and expenses of the Office of Interparliamentary
 4 Affairs, \$859,000; for other authorized employees,
 5 \$484,832; and for salaries and expenses of the Historian,
 6 \$170,000.

7 ALLOWANCES AND EXPENSES

8 For allowances and expenses as authorized by House
 9 resolution or law, \$302,165,206, including: supplies, mate-
 10 rials, administrative costs and Federal tort claims,
 11 \$3,696,118; official mail for committees, leadership of-
 12 fices, and administrative offices of the House, \$201,000;
 13 Government contributions for health, retirement, Social
 14 Security, and other applicable employee benefits,
 15 \$272,548,016; Business Continuity and Disaster Recov-
 16 ery, \$17,112,072, of which \$5,000,000 shall remain avail-
 17 able until expended; transition activities for new members
 18 and staff, \$4,125,000; Wounded Warrior Program
 19 \$2,175,000, to remain available until expended; Office of
 20 Congressional Ethics, \$1,548,000; and miscellaneous
 21 items including purchase, exchange, maintenance, repair
 22 and operation of House motor vehicles, interparliamentary
 23 receptions, and gratuities to heirs of deceased employees
 24 of the House, \$760,000.

ADMINISTRATIVE PROVISIONS

1 SEC. 101. (a) ~~REQUIRING AMOUNTS REMAINING IN~~
2 ~~MEMBERS' REPRESENTATIONAL ALLOWANCES TO BE~~
3 ~~USED FOR DEFICIT REDUCTION OR TO REDUCE THE~~
4 ~~FEDERAL DEBT.~~—Notwithstanding any other provision of
5 law, any amounts appropriated under this Act for
6 “HOUSE OF REPRESENTATIVES—Salaries and Ex-
7 penses—Members' Representational Allowances” shall be
8 available only for fiscal year 2013. Any amount remaining
9 after all payments are made under such allowances for fis-
10 cal year 2013 shall be deposited in the Treasury and used
11 for deficit reduction (or, if there is no Federal budget def-
12 icit after all such payments have been made, for reducing
13 the Federal debt, in such manner as the Secretary of the
14 Treasury considers appropriate).

15 (b) ~~REGULATIONS.~~—The Committee on House Ad-
16 ministration of the House of Representatives shall have
17 authority to prescribe regulations to carry out this section.

18 (c) ~~DEFINITION.~~—As used in this section, the term
19 “Member of the House of Representatives” means a Rep-
20 resentative in, or a Delegate or Resident Commissioner
21 to, the Congress.

22 SEC. 102. (a) Section 109(a) of the Legislative
23 Branch Appropriations Act, 1998 (2 U.S.C. 95d(a)) is
24 amended by striking the period at the end and inserting
25

1 the following: “, and for reimbursing the Secretary of
 2 Labor for any amounts paid with respect to unemployment
 3 compensation payments for former employees of the
 4 House.”.

5 (b) The amendment made by subsection (a) shall
 6 apply with respect to fiscal year 2013 and each succeeding
 7 fiscal year.

8 SEC. 103. (a) Section 101(e)(2) of the Legislative
 9 Branch Appropriations Act, 1993 (2 U.S.C. 95b(e)(2)) is
 10 amended by striking “and ‘Allowances and Expenses’”
 11 and inserting the following: “‘Allowances and Expenses’,
 12 the heading for any joint committee under the heading
 13 ‘Joint Items’ (to the extent that amounts appropriated for
 14 the joint committee are disbursed by the Chief Adminis-
 15 trative Officer of the House of Representatives), and ‘Of-
 16 fice of the Attending Physician’”.

17 (b) The amendment made by subsection (a) shall
 18 apply with respect to fiscal year 2013 and each succeeding
 19 fiscal year.

20 OVERSIGHT OF OFFICE OF INSPECTOR GENERAL

21 SEC. 104. (a) OVERSIGHT.—The Office of the Inspee-
 22 tor General of the House of Representatives shall provide
 23 the Committee on Appropriations of the House of Rep-
 24 resentatives with a copy of each audit and investigative
 25 report the Office produces, and shall consult regularly

1 with such Committee with respect to the Office's oper-
 2 ations:

3 (b) ~~EFFECTIVE DATE.~~—This section shall apply with
 4 respect to fiscal year 2013 and each succeeding fiscal year.

5 JOINT ITEMS

6 For Joint Committees, as follows:

7 JOINT ECONOMIC COMMITTEE

8 For salaries and expenses of the Joint Economic
 9 Committee, \$4,203,000, to be disbursed by the Secretary
 10 of the Senate.

11 JOINT COMMITTEE ON TAXATION

12 For salaries and expenses of the Joint Committee on
 13 Taxation, \$10,004,000, to be disbursed by the Chief Ad-
 14 ministrative Officer of the House of Representatives.

15 For other joint items, as follows:

16 OFFICE OF THE ATTENDING PHYSICIAN

17 For medical supplies, equipment, and contingent ex-
 18 penses of the emergency rooms, and for the Attending
 19 Physician and his assistants, including: (1) an allowance
 20 of \$2,175 per month to the Attending Physician; (2) an
 21 allowance of \$1,300 per month to the Senior Medical Offi-
 22 cer; (3) an allowance of \$725 per month each to three
 23 medical officers while on duty in the Office of the Attend-
 24 ing Physician; (4) an allowance of \$725 per month to 2
 25 assistants and \$580 per month each not to exceed 11 as-

1 sistants on the basis heretofore provided for such assist-
 2 ants; and (5) \$2,603,000 for reimbursement to the De-
 3 partment of the Navy for expenses incurred for staff and
 4 equipment assigned to the Office of the Attending Physi-
 5 cian, which shall be advanced and credited to the applica-
 6 ble appropriation or appropriations from which such sala-
 7 ries, allowances, and other expenses are payable and shall
 8 be available for all the purposes thereof, \$3,467,000, to
 9 be disbursed by the Chief Administrative Officer of the
 10 House of Representatives.

11 OFFICE OF CONGRESSIONAL ACCESSIBILITY SERVICES

12 SALARIES AND EXPENSES

13 For salaries and expenses of the Office of Congres-
 14 sional Accessibility Services, \$1,363,000, to be disbursed
 15 by the Secretary of the Senate.

16 CAPITOL POLICE

17 SALARIES

18 For salaries of employees of the Capitol Police, in-
 19 cluding overtime, hazardous duty pay, and Government
 20 contributions for health, retirement, social security, pro-
 21 fessional liability insurance, and other applicable employee
 22 benefits, \$297,133,000, to be disbursed by the Chief of
 23 the Capitol Police or his designee.

For necessary expenses of the Capitol Police, including motor vehicles, communications and other equipment, security equipment and installation, uniforms, weapons, supplies, materials, training, medical services, forensic services, stenographic services, personal and professional services, the employee assistance program, the awards program, postage, communication services, travel advances, relocation of instructor and liaison personnel for the Federal Law Enforcement Training Center, and not more than \$5,000 to be expended on the certification of the Chief of the Capitol Police in connection with official representation and reception expenses, \$63,004,000, of which \$2,700,000 shall remain available until September 30, 2015 to be disbursed by the Chief of the Capitol Police or his designee: *Provided*, That, notwithstanding any other provision of law, the cost of basic training for the Capitol Police at the Federal Law Enforcement Training Center for fiscal year 2013 shall be paid by the Secretary of Homeland Security from funds available to the Department of Homeland Security.

1 ADMINISTRATIVE PROVISIONS
2 (INCLUDING TRANSFER OF FUNDS)
3 AUTHORITY TO TRANSFER AMOUNTS BETWEEN SALARIES
4 AND GENERAL EXPENSES

5 SEC. 1001. During fiscal year 2013 and any suc-
6 ceeding fiscal year, the Capitol Police may transfer
7 amounts appropriated for the fiscal year between the cat-
8 egory for salaries and the category for general expenses,
9 upon the approval of the Committees on Appropriations
10 of the House of Representatives and Senate.

11 FUNDS AVAILABLE FOR WORKERS COMPENSATION
12 PAYMENTS

13 SEC. 1002. (a) IN GENERAL.—Available balances of
14 expired United States Capitol Police appropriations shall
15 be available to the Capitol Police to make the deposit to
16 the credit of the Employees' Compensation Fund required
17 by section 8147(b) of title 5, United States Code.

18 (b) CONFORMING AMENDMENT.—Section 1018 of the
19 Legislative Branch Appropriations Act, 2003 (2 U.S.C.
20 1907) is amended by striking subsection (f).

21 (c) EFFECTIVE DATE.—This section shall apply with
22 respect to appropriations for fiscal year 2013 and each
23 fiscal year thereafter.

OFFICE OF COMPLIANCE

SALARIES AND EXPENSES

For salaries and expenses of the Office of Compliance, as authorized by section 305 of the Congressional Accountability Act of 1995 (2 U.S.C. 1385), \$3,817,000, of which \$527,500 shall remain available until September 30, 2014: *Provided*, That not more than \$500 may be expended on the certification of the Executive Director of the Office of Compliance in connection with official representation and reception expenses.

ADMINISTRATIVE PROVISION

SEC. 1101. (a) The second sentence of section 415(a) of the Congressional Accountability Act of 1995 (2 U.S.C. 1415(a)) is amended to read as follows: “There are appropriated for such account such sums as may be necessary to pay such awards and settlements.”.

(b) The amendment made by subsection (a) shall apply with respect to fiscal year 2013 and each succeeding fiscal year.

CONGRESSIONAL BUDGET OFFICE

SALARIES AND EXPENSES

For salaries and expenses necessary for operation of the Congressional Budget Office, including not more than \$6,000 to be expended on the certification of the Director

1 of the Congressional Budget Office in connection with offi-
 2 cial representation and reception expenses, \$44,280,000.

3 ADMINISTRATIVE PROVISION

4 ACCEPTANCE OF VOLUNTARY STUDENT SERVICES

5 SEC. 1201. (a) Section 3111(e) of title 5, United
 6 States Code, is amended—

7 (1) by striking “(e)” and inserting “(e)(1)”,
 8 and

9 (2) by adding at the end the following new
 10 paragraph:

11 “(2) In this section, the term ‘agency’ includes the
 12 Congressional Budget Office, except that in the case of
 13 the Congressional Budget Office—

14 “(A) any student who provides voluntary service
 15 in accordance with this section shall be considered
 16 an employee of the Congressional Budget Office for
 17 purposes of section 203 of the Congressional Budget
 18 Act of 1974 (relating to the level of confidentiality
 19 of budget data); and

20 “(B) the authority granted to the Office of Per-
 21 sonnel Management under this section shall be exer-
 22 cised by the Director of the Congressional Budget
 23 Office.”.

1 (b) The amendment made by subsection (a) shall
2 apply with respect to fiscal year 2013 and each succeeding
3 fiscal year.

4 ARCHITECT OF THE CAPITOL

5 GENERAL ADMINISTRATION

6 For salaries for the Architect of the Capitol, and
7 other personal services, at rates of pay provided by law;
8 for surveys and studies in connection with activities under
9 the care of the Architect of the Capitol; for all necessary
10 expenses for the general and administrative support of the
11 operations under the Architect of the Capitol including the
12 Botanic Garden; electrical substations of the Capitol; Sen-
13 ate and House office buildings, and other facilities under
14 the jurisdiction of the Architect of the Capitol; including
15 furnishings and office equipment; including not more than
16 \$5,000 for official reception and representation expenses;
17 to be expended as the Architect of the Capitol may ap-
18 prove; for purchase or exchange, maintenance, and oper-
19 ation of a passenger motor vehicle, \$90,755,000, of which
20 \$999,000 shall remain available until September 30, 2017.

21 CAPITOL BUILDING

22 For all necessary expenses for the maintenance, care
23 and operation of the Capitol, \$28,591,000, of which
24 \$3,500,000 shall remain available until September 30,
25 2017.

1 CAPITOL GROUNDS

2 For all necessary expenses for care and improvement
3 of grounds surrounding the Capitol, the Senate and House
4 office buildings, and the Capitol Power Plant,
5 \$17,152,000, of which \$7,300,000 shall remain available
6 until September 30, 2017.

7 HOUSE OFFICE BUILDINGS

8 For all necessary expenses for the maintenance, care
9 and operation of the House office buildings, \$83,964,000,
10 of which \$19,362,000 shall remain available until Sep-
11 tember 30, 2017.

12 In addition, for a payment to the House Historic
13 Buildings Revitalization Trust Fund, \$30,000,000, shall
14 remain available until expended.

15 CAPITOL POWER PLANT

16 For all necessary expenses for the maintenance, care
17 and operation of the Capitol Power Plant; lighting, heat-
18 ing, power (including the purchase of electrical energy)
19 and water and sewer services for the Capitol, Senate and
20 House office buildings, Library of Congress buildings, and
21 the grounds about the same; Botanic Garden, Senate ga-
22 rage, and air conditioning refrigeration not supplied from
23 plants in any of such buildings; heating the Government
24 Printing Office and Washington City Post Office, and
25 heating and chilled water for air conditioning for the Su-

1 preme Court Building, the Union Station complex, the
 2 Thurgood Marshall Federal Judiciary Building and the
 3 Folger Shakespeare Library, expenses for which shall be
 4 advanced or reimbursed upon request of the Architect of
 5 the Capitol and amounts so received shall be deposited
 6 into the Treasury to the credit of this appropriation,
 7 \$108,616,000, of which \$23,404,000 shall remain avail-
 8 able until September 30, 2017: *Provided*, That not more
 9 than \$9,400,000 of the funds credited or to be reimbursed
 10 to this appropriation as herein provided shall be available
 11 for obligation during fiscal year 2013.

12 LIBRARY BUILDINGS AND GROUNDS

13 For all necessary expenses for the mechanical and
 14 structural maintenance, care and operation of the Library
 15 buildings and grounds, \$30,660,000, of which \$4,900,000
 16 shall remain available until September 30, 2017.

17 CAPITOL POLICE BUILDINGS, GROUNDS, AND SECURITY

18 For all necessary expenses for the maintenance, care
 19 and operation of buildings, grounds and security enhance-
 20 ments of the United States Capitol Police, wherever lo-
 21 cated, the Alternate Computer Facility, and AOC security
 22 operations, \$20,867,000, of which \$2,840,000 shall re-
 23 main available until September 30, 2017.

1 BOTANIC GARDEN

2 For all necessary expenses for the maintenance, care
 3 and operation of the Botanic Garden and the nurseries;
 4 buildings, grounds, and collections; and purchase and ex-
 5 change, maintenance, repair, and operation of a passenger
 6 motor vehicle; all under the direction of the Joint Com-
 7 mittee on the Library, \$12,140,000 (reduced by
 8 \$1,235,000): *Provided*, That of the amount made available
 9 under this heading, the Architect of the Capitol may obli-
 10 gate and expend such sums as may be necessary for the
 11 maintenance, care and operation of the National Garden
 12 established under section 307E of the Legislative Branch
 13 Appropriations Act, 1989 (2 U.S.C. 2146), upon vouchers
 14 approved by the Architect of the Capitol or a duly author-
 15 ized designee.

16 CAPITOL VISITOR CENTER

17 For all necessary expenses for the operation of the
 18 Capitol Visitor Center, \$21,276,000.

19 ADMINISTRATIVE PROVISION

20 FUNDS AVAILABLE FOR WORKERS COMPENSATION

21 PAYMENTS

22 SEC. 1301. (a) IN GENERAL.—Available balances of
 23 expired Architect of the Capitol appropriations shall be
 24 available to the Architect of the Capitol to make the de-

1 posit to the credit of the Employees' Compensation Fund
 2 required by section 8147(b) of title 5, United States Code.

3 (b) ~~EFFECTIVE DATE.~~—This section shall apply with
 4 respect to appropriations for fiscal year 2013 and each
 5 fiscal year thereafter.

6 LIBRARY OF CONGRESS

7 SALARIES AND EXPENSES

8 For necessary expenses of the Library of Congress
 9 not otherwise provided for, including development and
 10 maintenance of the Library's catalogs; custody and custo-
 11 dial care of the Library buildings; special clothing; clean-
 12 ing; laundering and repair of uniforms; preservation of
 13 motion pictures in the custody of the Library; operation
 14 and maintenance of the American Folklife Center in the
 15 Library; activities under the Civil Rights History Project
 16 Act of 2009; preparation and distribution of catalog
 17 records and other publications of the Library; hire or pur-
 18 chase of one passenger motor vehicle; and expenses of the
 19 Library of Congress Trust Fund Board not properly
 20 chargeable to the income of any trust fund held by the
 21 Board, \$422,024,000, of which not more than \$6,000,000
 22 shall be derived from collections credited to this appropria-
 23 tion during fiscal year 2013, and shall remain available
 24 until expended, under the Act of June 28, 1902 (chapter
 25 1301, 32 Stat. 480, 2 U.S.C. 150) and not more than

1 \$350,000 shall be derived from collections during fiscal
 2 year 2013 and shall remain available until expended for
 3 the development and maintenance of an international legal
 4 information database and activities related thereto: *Pro-*
 5 *vided*, That the Library of Congress may not obligate or
 6 expend any funds derived from collections under the Act
 7 of June 28, 1902, in excess of the amount authorized for
 8 obligation or expenditure in appropriations Acts: *Provided*
 9 *further*, That the total amount available for obligation
 10 shall be reduced by the amount by which collections are
 11 less than \$6,350,000: *Provided further*, That of the total
 12 amount appropriated, not more than \$12,000 may be ex-
 13 pended, on the certification of the Librarian of Congress,
 14 in connection with official representation and reception ex-
 15 penses for the Overseas Field Offices: *Provided further*,
 16 That of the total amount appropriated, \$7,068,000 shall
 17 remain available until expended for the digital collections
 18 and educational curricula program.

19 COPYRIGHT OFFICE

20 SALARIES AND EXPENSES

21 For all necessary expenses of the Copyright Office,
 22 \$52,136,000, of which not more than \$28,029,000, to re-
 23 main available until expended, shall be derived from collec-
 24 tions credited to this appropriation during fiscal year 2013
 25 under section 708(d) of title 17, United States Code: *Pro-*

~~1~~ *vided*, That the Copyright Office may not obligate or ex-
~~2~~ pend any funds derived from collections under such sec-
~~3~~ tion, in excess of the amount authorized for obligation or
~~4~~ expenditure in appropriations Acts: *Provided further*, That
~~5~~ not more than \$5,582,000 shall be derived from collections
~~6~~ during fiscal year 2013 under sections 111(d)(2),
~~7~~ 119(b)(2), 803(e), 1005, and 1316 of such title: *Provided*
~~8~~ *further*, That the total amount available for obligation
~~9~~ shall be reduced by the amount by which collections are
~~10~~ less than \$33,611,000: *Provided further*, That not more
~~11~~ than \$100,000 of the amount appropriated is available for

6 SALARIES AND EXPENSES

7 For necessary expenses to carry out the provisions

The Architect of the Capitol, in consultation with the District of Columbia, is authorized to maintain and improve the landscape features, excluding streets, in the irregular shaped grassy areas bounded by Washington Avenue, SW on the northeast, Second Street, SW, on the west, Square 582 on the south, and the beginning of the I-395 tunnel on the southeast.

LIMITATION ON TRANSFERS

SEC. 207. None of the funds made available in this Act may be transferred to any department, agency, or instrumentality of the United States Government, except pursuant to a transfer made by, or transfer authority provided in, this Act or any other appropriation Act.

GUIDED TOURS OF THE CAPITOL

SEC. 208. (a) Except as provided in subsection (b), none of the funds made available to the Architect of the Capitol in this Act may be used to eliminate or restrict guided tours of the United States Capitol which are led by employees and interns of offices of Members of Congress and other offices of the House of Representatives and Senate.

(b) At the direction of the Capitol Police Board, or at the direction of the Architect of the Capitol with the approval of the Capitol Police Board, guided tours of the

1 United States Capitol which are led by employees and in-
2 terns described in subsection (a) may be suspended tempo-
3 rarily or otherwise subject to restriction for security or re-
4 lated reasons to the same extent as guided tours of the
5 United States Capitol which are led by the Architect of
6 the Capitol.

7 DELIVERY OF BILLS AND RESOLUTIONS

8 SEC. 209. None of the funds made available in this
9 Act may be used to deliver a printed copy of a bill, joint
10 resolution, or resolution to the office of a Member of the
11 House of Representatives (including a Delegate or Resi-
12 dent Commissioner to the Congress) unless the Member
13 requests a copy.

14 DELIVERY OF CONGRESSIONAL RECORD

15 SEC. 210. None of the funds made available by this
16 Act may be used to deliver a printed copy of any version
17 of the Congressional Record to the office of a Member of
18 the House of Representatives (including a Delegate or
19 Resident Commissioner to the Congress).

20 LIMITATION ON AMOUNT AVAILABLE TO LEASE VEHICLES

21 SEC. 211. None of the funds made available in this
22 Act may be used by the Chief Administrative Officer of
23 the House of Representatives to make any payments from
24 any Members' Representational Allowance for the leasing
25 of a vehicle, excluding mobile district offices, in an aggre-

1 gate amount that exceeds \$1,000 for the vehicle in any
 2 month.

3 AUTHORIZING COMMERCIAL ACTIVITY ON UNION SQUARE

4 SEC. 212. (a) CONTINUATION OF TYPES OF ACTIVITY
 5 PREVIOUSLY AUTHORIZED.—

6 (1) IN GENERAL.—Notwithstanding any limita-
 7 tions on the use of the United States Capitol
 8 Grounds (including section 5104(c) of title 40,
 9 United States Code), the Chief of the United States
 10 Capitol Police (hereafter referred to as the
 11 “Chief”)—

12 (A) may issue a permit authorizing a per-
 13 son to engage in commercial activity in Union
 14 Square if the activity is similar to the types of
 15 commercial activity permitted in Union Square
 16 prior to the transfer of jurisdiction and control
 17 of Union Square to the Architect of the Capitol
 18 under section 1202 of the Legislative Branch
 19 Appropriations Act, 2012 (Public Law 112–74);

 22 a permit, may require the person to whom the
 23 permit is issued to pay a fee to cover any costs

13 *“(e) UNION SQUARE.—The Capitol Grounds shall in-*
 14 *clude the property transferred to the Architect of the Capitol*
 15 *under section 1202 of title I of division G of the Consoli-*
 16 *dated Appropriations Act, 2012 (Public Law 112–74).”;*
 17 *and*

18 *(2) by adding at the end the following:*

19 **“§5110. Use of Union Square**

20 *“(a) DEFINITION.—In this section, the term ‘Union*
 21 *Square’ means the property transferred to the Architect of*
 22 *the Capitol under section 1202 of title I of division G of*
 23 *the Consolidated Appropriations Act, 2012 (Public Law*
 24 *112–74).*

1 “(b) *COMMERCIAL PERMITTING.*—Notwithstanding
 2 sections 5102, 5103, 5104, 5105, 5106, and 5109, and in
 3 accordance with the regulations promulgated under sub-
 4 section (f), the Capitol Police may issue a permit author-
 5 izing a person to engage in commercial activity in Union
 6 Square in a manner that will not interfere with Congress.

7 “(c) *FEES.*—

8 “(1) *IN GENERAL.*—In accordance with the regu-
 9 lations promulgated under subsection (f)(2), the Cap-
 10 itol Police may collect—

11 “(A) *fees for the processing of an applica-*
 12 *tion to use Union Square, including any admin-*
 13 *istrative and personnel costs incurred by the*
 14 *Capitol Police or the Architect of the Capitol;*
 15 *and*

16 “(B) *fees for the use of Union Square, in-*
 17 *cluding all costs incurred by the Capitol Police*
 18 *or the Architect of the Capitol resulting from the*
 19 *use of Union Square, including the costs to mon-*
 20 *itor the permitted activity.*

21 “(2) *ESTABLISHMENT OF FEES BY CAPITOL PO-*
 22 *LICE.*—

23 “(A) *IN GENERAL.*—The Capitol Police,
 24 after consultation with the Architect of the Cap-

1 itol, shall establish the amount of the fees author-
2 ized under paragraph (1).

3 “(B) *ADJUSTMENT.*—*The Capitol Police*
4 *shall periodically review and, subject to approval*
5 *by the Committee on Rules and Administration*
6 *of the Senate and the Committee on House Ad-*
7 *ministration of the House of Representatives, ad-*
8 *just the amount of the fees authorized under*
9 *paragraph (1), as necessary.*

10 “(d) *ACCOUNT, DEPOSITS, DISBURSEMENTS, AND*
11 *TRANSFERS.*—

12 “(1) *ACCOUNT.*—*There is established in the*
13 *Treasury of the United States an account for the Cap-*
14 *itol Police to be known as the ‘Union Square Com-*
15 *mercial Activities Account’ (in this section referred to*

17 “(2) *DEPOSITS IN THE UNION SQUARE AC-*
18 *COUNT.*—*There shall be deposited in the Union*

“(4) REIMBURSEMENT AND TRANSFER AUTHORITY.—

“(A) REIMBURSEMENT OF THE ARCHITECT OF THE CAPITOL.—The Capitol Police shall transfer from the Union Square Account to the appropriations account appropriated under the heading ‘CAPITOL GROUNDS’ under the heading ‘ARCHITECT OF THE CAPITOL’ an amount equal to the costs incurred by the Architect of the Capitol relating to the use of Union Square.

“(B) TRANSFER TO OTHER ACCOUNTS.—The Capitol Police may transfer from the Union Square Account to any applicable appropriations accounts of the Capitol Police amounts necessary to reimburse the accounts for costs incurred relating to the use of Union Square.

“(C) AVAILABILITY.—Any amounts transferred under this paragraph shall be available for the same purpose as the appropriation account to which such sums are transferred and shall remain available until expended.

“(e) AUDIT.—As determined appropriate by the Inspector General of the Capitol Police or the Inspector Gen-

1 eral of the Architect of the Capitol, or as directed by the
 2 Committee on House Administration of the House of Rep-
 3 resentatives or the Committee on Rules and Administration
 4 of the Senate, either such Inspector General shall audit the
 5 Union Square Account.

6 “(f) *REGULATIONS.*—Subject to approval by the Com-
 7 mittee on Rules and Administration of the Senate and the
 8 Committee on House Administration of the House of Rep-
 9 resentatives, the Capitol Police Board shall promulgate reg-
 10 ulations relating to the use of Union Square for commercial
 11 activity, which shall—

12 “(1) describe the types of commercial activity
 13 authorized (which shall be substantially similar to the
 14 types of commercial activity permitted in Union
 15 Square on the day before the date of enactment of the
 16 Consolidated Appropriations Act, 2012 (Public Law
 17 112–74)); and

18 “(2) provide for the payment of fees and costs
 19 that are substantially similar to those collected by the
 20 National Park Service on the day before the date of
 21 enactment of the Consolidated Appropriations Act,
 22 2012 (Public Law 112–74)).”.

23 (b) *AUTHORITY TO WAIVE CERTAIN RESTRICTIONS*
 24 *DURING TRANSITION PERIOD.*—

1 (1) *DEFINITION.*—*In this subsection, the term*
2 *“Union Square” has the meaning given that term in*
3 *section 5110 of title 40, United States Code, as added*
4 *by this section.*

5 (2) *AUTHORITY.*—*Any waiver granted by the*
6 *Capitol Police Board, in consultation with the Cap-*
7 *itol Police, of the application of any limitation on the*
8 *use of lands under the jurisdiction of the Architect of*
9 *the Capitol or the Capitol Grounds (including section*
10 *5104 of title 40, United States Code) with respect to*
11 *a person engaging in commercial activity in Union*
12 *Square during the period described in paragraph (3)*
13 *shall be deemed an authorized waiver if the activity*
14 *would have been treated as permissible commercial*
15 *activity under the regulations promulgated by the*

3 *(c) NO EFFECT ON PERMITS ISSUED PRIOR TO TRANS-*
 4 *FER.—Nothing in this section, the amendments made by*
 5 *this section, or section 1202 of title I of division G of the*
 6 *Consolidated Appropriations Act, 2012 (Public Law 112–*
 7 *74) shall be construed to affect any permit for engaging in*
 8 *commercial activity in Union Square (as defined in section*
 9 *5110 of title 40, United States Code, as added by this sec-*
 10 *tion) which was issued by the National Park Service before*
 11 *the date of enactment of the Consolidated Appropriations*
 12 *Act, 2012.*

13 *(d) TECHNICAL AND CONFORMING AMENDMENTS.—*

14 *(1) IN GENERAL.—Section 9 of the Act entitled*
 15 *“An Act to define the area of the United States Cap-*
 16 *itol Grounds, to regulate the use thereof, and for other*
 17 *purposes”, approved July 31, 1946 (2 U.S.C. 1961)*
 18 *is amended by adding at the end the following:*

19 *“(e) For purposes of this Act, ‘United States Capitol*
 20 *Buildings and Grounds’ shall include the property trans-*
 21 *ferred to the Architect of the Capitol under section 1202*
 22 *of title I of division G of the Consolidated Appropriations*
 23 *Act, 2012 (Public Law 112–74).”.*
